INTRODUCTIONS

PUBLIC INPUT

APPROVAL OF MINUTES: **MOTION** by Patrick Perry to approve the minutes as written. Seconded by Todd Claflin. Passed unanimously.

LEADERSHIP ELECTION OF CHAIR & VICE CHAIR: There were nominations last meeting for Todd Claflin as Chair and Jerry Green as Vice Chair. There was a self-nomination by Glenn Reeves for either position. MOTION by Rich Foster to close nominations. Seconded by Jim Huber. MOTION by Patrick Perry to vote by the raise on hand. Seconded by Glenn Reeves. Voting for Chair: 10 votes for Todd Claflin and 0 votes for Glenn Reeves. Todd Claflin will be Chair. Voting for Vice-Chair: 9 votes for Jerry Green and 0 votes for Glenn Reeves. Abstained by Jerry Green. Jerry Green will be Vice Chair.

Glenn Reeves suggested the Bylaws Committee consider clarifying the election procedure in the by laws—who nominates, the voting, etc.

COMMITTEE UPDATES:

1. PARKING & GROUND TRANSPORTATION: Craig Carter reported that they have been attempting to get in touch with City Council Member Lisa Adams in Sugar House. Craig discussed the issue with a resident George Chapman. Craig said Mr. Chapman will be a real advocate for the City.

Mary Ann Cowan said the accessible parking requirement is now 1 in 6 van accessible stalls and that kicks in when the parking lot is restriped. Discussion about challenges with on-street parking. Jerry

Green asked if this topic is something the council would like to survey and make recommendations on. Mary Ann said on-street parking is not currently mandated. Right now, there are only the Access Board right of way guidelines. Michael Barnes suggested boycotting businesses that don't provide accessible parking. Jerry clarified that when we talk about private and public parking we are referring to land ownership. Todd Claflin said we ought to look at the redevelopment in Sugar House and see what the City can do to ensure the required parking is reviewed. Discussion about how the council should approach this issue. Todd suggested the Parking & Ground Transportation Committee take on the issue and bring a recommendation to the council.

Michael Stott said committees can email their questions to him and he can send them to the appropriate departments for responses. If email does not suffice, Michael S can set up a meeting with Department Administrators with the committee for a discussion. Michael S cautioned the committees to not give their opinions and recommendations directly to administrators but bring their recommendations back to the council.

- LEGISLATION / CITY COUNCIL / BY-LAWS: Rich Foster said there is nothing to report. Rich suggested the bylaws change should be made by the committee as a whole rather than the committee. The committee will identify a chair and reconvene on the bylaws proposal and other issues.
- ARCHITECTURAL BARRIERS / ACCESSIBILITY: Glenn Reeves reported that due to an accident and his hospital stay he was unable to do anything with the committee. Michael Stott said he is drafting changes to city policy on the ADA and will ask the committee then the new group for their input on those changes.
- 4. HOUSING / EMPLOYMENT / MEMBERSHIP: The committee has a draft ready and asked everyone for input. The committee needs to meet and finalize the draft to be ready to propose it next meeting.
