A. The emergency egress window in the basement bedroom is deficient in dimension and net openable area.

Case Number HAZ2013-01503 @ 419 East Harrison Avenue

Wendy Madrill, Housing/Zoning Officer **City Council District Five**

- A. The stairway leading to the basement is deficient in headroom.
- B. The mechanical duct and structural beam encroaches into the required ceiling height.

- C. The egress window in the basement bedroom is deficient in dimension and net openable area.
- D. The window sill for the same window is excessive in height.

- A. Rachel White motioned to deny the appeal for the deficiency in headroom height because the lack of headroom height presents a safety concern. Chirs Atkin seconded the motion and the motion passed.
- B. Susan Fleming motioned to approve the appeal for the mechanical duct and structural beam encroaching in the required ceiling height because it would require structural alterations to the bearing wall, beam and the ductwork would have to be relocated, provided the leading edge is posted with reflective tape. Rachel White seconded the motion and the motion passed.
- C. Rachel White motioned to deny the appeal for the deficiency in dimension and net openable area of the egress window because the deficiency is excessive. Susan Fleming seconded the motion and the motion passed.
- D. Susan Fleming motioned to approve the appeal for excessive window sill height, provided a permanent step or ladder is installed under the window. Rachel White seconded the motion and the motion passed.
