Unit #1

1. The basement bedroom window is insufficient in dimension and net openable area for emergency egress.

Marlene Jennings motioned to deny the appeal for insufficient dimension and net openable area for emergency egress. John Morgan seconded the motion and the motion passed. Chris Atkin, Marlene Jennings and John Morgan voted against the appeal.

2. The same window is excessive in sill height.

Marlene Jennings motioned to approve the appeal for excessive sill height. John Morgan seconded the motion and the motion passed. Chris Atkin, Marlene Jennings and John Morgan voted in favor of the appeal.

3. The clearance in front of the basement bedroom window is insufficient in front of the net openable area for emergency egress.

Marlene Jennings motioned to deny the appeal for insufficient clearance in front of the net openable area for emergency egress of the basement bedroom window. John Morgan seconded the motion and the motion passed. Chris Atkin, Marlene Jennings and John Morgan voted against the appeal.

4. The window dimensions for the basement living room and basement bedroom are insufficient for providing natural light and ventilation.

Marlene Jennings motioned to deny the appeal for insufficient dimension of the windows in the basement living room and basement bedroom to provide natural light and ventilation, but the motion failed for lack of a second. John Morgan motioned to approve the appeal. Chris Atkin seconded the motion and the motion passed. Chris Atkin and John Morgan voted in favor of the appeal. Marlene Jennings voted against the appeal.

5. The headroom of the stairway leading to the basement is insufficient in height.

Chris Atkin motioned to approve the appeal for insufficient headroom height of the stairway leading to the basement. Marlene Jennings seconded the motion and the motion passed. Chris Atkin, Marlene Jennings and John Morgan voted in favor of the appeal.

Unit #8

1. The basement is all one room and is currently used for sleeping. Both windows are deficient in dimension and net openable area for emergency egress.

Marlene Jennings motioned to deny the appeal for insufficient dimension and net openable area for emergency egress of both windows. Chris Atkin seconded the motion and the motion passed. Chris Atkin, Marlene Jennings and John Morgan voted against the appeal.

2. The sill of the same windows are excessive in height.

John Morgan motioned to approve the appeal for excessive sill height provided a permanent step or ladder is installed under one of the windows. Chris Atkin seconded the motion and the motion passed. Chris Atkin, Marlene Jennings and John Morgan voted in favor of the appeal.

3. Both windows combined in the main room are insufficient in dimension and net openable area to provide natural light and ventilation.

Marlene Jennings motioned to deny the appeal for insufficient window dimension of both windows combined in the main room to provide natural light and ventilation, but the motion failed for lack of a second. John Morgan motioned to approve the appeal. Chris Atkin seconded the motion and the motion passed. Chris Atkin and John Morgan voted in favor of the appeal. Marlene Jennings voted against the appeal.

4. The headroom in the stairway leading to the basement is insufficient in height.

Chris Atkin motioned to approve the appeal for insufficient headroom height of the stairway leading to the basement. John Morgan seconded the motion and the motion passed. Chris Atkin, Marlene Jennings and John Morgan voted in favor of the appeal.

1. Mulitple bedroom windows are insufficient in size for emergency egress.

2. Access for the hot water heater and furnace is through the wall of the bedroom closet.
