### **Meeting Minutes:**

Approved August 2018 Meeting Minutes

Police Use of Force Report discussion led by Mike Brown, Chief of Police, Salt Lake City Police Department

Chief Brown discussed the Police Use of Force Report with the commission. They spoke of making it a living document, missing updates, police body cam footage, documentation of policy changes, summaries of use of force incidents as they happen, and creating a web portal for public access. Also discussed were Police Data Initiative, use of force and crime statistics online availability, Cultivating Compassion (internal trainings reports), Citations in School Report (dramatically decreased number of citations issued in schools), Implicit Bias Training, De-escalation Awards, diversity recruitment, SLCPD employee demographic statistics, SLCPD hiring practices/process, youth recruitment, outreach to diverse communities(creating a comfort level for reporting

crimes in our immigrant communities), treatment of LGBTQ after an arrest, the refugee community vs other people of color, Operation Rio Grande, disbursement of crime, crime reporting, private property vs public property, treatment beds, Medicaid expansion, and the DEA 360 Grant.

Commission would like to form a subcommittee to provide the Police Chief with some recommendations.

Commission voted in favor of drafting a letter in favor/opposite editorial (Op-Ed) recognizing health care as a human right in favor of Utah Proposition 3, Medicaid Expansion Initiative (2018). Unanimous vote.
