Housing Discussion:

June Hiatt, Director of Policy and Advocacy, Utah Housing Coalition

Discussed the current affordable housing crisis Salt Lake City is facing.

- A need of approximately 47,000 units for individuals and families that make less than the area's median income
 - A family of 4 would make less than \$24,000 annually to be considered to be making less than the area's median income.

Human rights in housing=civil rights - direct correlation to where a person lives and how their life turns out. Salt Lake City is better off than other places due to progressive housing policies and active non-profits and community groups that fight to protect marginalized communities' rights (LGBTQ, disability community, etc). Utah can be better at working to protect racial segregation in housing. Housing is also correlated with access to food, health outcomes, access to education/schools with adequate resources, and the long term progression of a person's education tract. Research shows that a community's education trends are a bigger influence on a child compared to how much education the parent of the child has. For example: if a neighborhood is primarily made up of people who have not completed high school, a child raised there is likely to drop out, compared to if a child is raised in a neighborhood primarily comprised of individuals who have completed college, children raised in that neighborhood are likely to go on to college themselves.

Recommendations to the HRC from the Utah Housing Coalition:

- Request that City Council and Housing and Neighborhood Development use the assessment tools created by HUD to ensure that housing plans are meeting the needs of the most under resourced communities.
- Encourage City Council to follow ordinances made by Denver and Los Angeles and provide legal representation for Eviction Court (for renters).
- Ensure that the City's housing plan addresses the lack of senior housing and housing for those living at 30% or below Area Median Income.
- Encourage the Mayor's Office and City Council to make comments regarding that attempted change to the Public Charge Rule.

Commission discussed how to approach making housing recommendations to the Mayor, and City Council.

Commission voted to create a housing package of recommendations to the Mayor.
