At the last HRC Meeting, Commissioner Chavez-Houck gave an update on the State's efforts for the Census 2020. State funding of \$75,000 for a state-wide digital campaign to inform Utahns about the upcoming Census 2020 was denied.

SLCo has allocated \$250,000 for this outreach effort. She advised Salt Lake City become an official partner with the current Census 2020 efforts and to possibly team up with Salt Lake County's efforts.

- 4. CEDAW Update

HRC Commissioners are working with Rob DeBirk and Victoria Baird on CEDAW Ordinance Framework.

According to Cities for CEDAW, there are nine U.S. cities that have implemented an ordinance within their communities.

- Cincinnati, Ohio
- Honolulu, Hawaii
- Lost Angeles, California
- Miami Dade County, Florida
- Pittsburgh, Pennsylvania
- San Francisco, California
- San Jose, California
- Santa Clara, California
- Washington, DC (proposed)

Cities for CEDAW provided guidance on <u>How to Implement CEDAW as a Local Ordinance</u>. According to them, there are three minimum requirements for successful implementation: **Gender Analysis:** analyze workforce, services and city budget to integrate gender considerations into daily operations and local agencies to institutionalize new approaches to equitable distribution of resources Report includes other demographics linked to gender – race, disability, immigration status and sexual orientations.

Oversight Body: community and government leaders needed to oversee implementation of action plans to implement programming and policies.

Funding: municipalities should allocate \$0.10-\$0.25 per woman resident to implement program and policy reforms outlined by CEDAW
