Grid City Brewing Conditional Use at approximately 10 S 800 West – A request by Justin Belliveau (owner) for Conditional Use approval for a small brewery and social club located at the above listed property. The applicant is proposing to build a new structure to accommodate the uses noted above as well as outdoor dining space on site. The property is currently vacant. The subject property is located in a TSA-UN-T (Transit Station Area Urban Neighborhood Transition) District, and in Council District 2 represented by Andrew Johnston. Peck Striping Conditional Use at approximately 1775 S Redwood Road - A request by Ken Campbell, Peck Striping, Inc., for Conditional Use approval to utilize outdoor storage in conjunction with the existing building which Peck Striping currently occupies at the above listed property. The subject property is located in the CC (Commercial Corridor) zoning district and is located in Council District 2, represented by Andrew Johnston. Mr. Stewart explained that the request was granted conditional use approval for outdoor storage in 2012 which expired. The Applicant is now re-applying for conditional use approval to store striping equipment outdoors. Staff reviewed the request, found that the request complied with the standards of review for conditional use approval and recommended approval. Mr. Stewart noted that the Applicant is aware of the requirements related to screening for outdoor storage, and that a condition was imposed which is to maintain the existing trees on the site to serve as additional screening.
