<u>PLNHLC2010-00206, Janke Certificate of Appropriateness for Major Alterations</u> – A request by the property owners, Matt Janke and Carrie Christopherson-Janke, for major alterations to the single family home located at approximately 1621 Laird Avenue. The property is located in the Harvard-Yale Neighborhood and Yalecrest National Register Historic District, and the R-1-5000 (Single Family Residential) zoning district.
