# Jan Hemming – Yalecrest Yes Heritage Preservation Committee

Here are the facts on surveys:

These are majority views – 73% of those responding said 'yes' to local historic district (LHD). Included many elderly people and many without computers.

On the survey of every home – State Historic Preservation Office confirms it is not a 'windshield survey' but a full reconnaissance survey.

# Ben Winchester – Yalecrest Preservationists for Property Rights

Give survey information

Support preservation but adamantly against LHD for Yalecrest. This has caused so much disruption over the last 9 months. Process & idea is opposed by over 70%. Similar with recent demolition ordinance.

Concern over why Yalecrest compatible infill ordinance (YCI) is not effective – working on proposals to amend this.

# Sally Patrick

Strongly support local historic district.

I have lived here twice, with period in Boston between. Moved here as single mother.

Under YCI some changes are unfortunate

Need protection for the architecture, mass & scale and housing diversity.

#### Sue Osten

Here we are again.

This is not a way to preserve character – 70% are against the LHD

Everyone who cares should find an alternative.

We will not be able to afford it.

# Jon Dewey

Strongly in support of a LHD. YCI is too ..... not effective. Ability to amend the YCI, as proposed by some, is not possible - we tried it two years ago.

We need the influence and consideration that come from being a LHD.

I am going through the process – at no extra cost.

Yalecrest is mentioned by both the City Council and Historic Landmark Commission.

#### **Brian Stephens**

Support LHD.

Do I believe restrictions are necessary for me? Rules & regulations are necessary to control self-interest.

400 + neighbors - support. 5000 SF mansions in Sandy

This is an all or nothing system – which is a problem.

Many people will not be able to do what they need to – based on personal experience recently. Not an evenly applied solution.

# **Libby Peterson**

Lived in neighborhood since 1982. Strong supporter of the LHD.

# **Cody Wallace**

Came here from Seattle & dazzled by this neighborhood.

Sad to see what is now under pressure.

#### **Norbert Bench**

To be here is an inspirational thing.

We have responsibilities to this neighborhood.

# Kathryn Fox

Here we do agree. Support the silent majority and the LHD.

Haven't been to previous meetings and not exposed to high level of emotion.

# Lynn Kennard

Support the LHD. My home is 1939 and my street has recently been removed from the area considered.

Concerned about demolitions & mega-homes.

Need to ensure it is livable for the 21<sup>st</sup> century. Need to address size, scale & compatibility. Also need to address facades.

# Jim Jenkin

Chair of Avenues Community Council.

The LHD works for us. Properties hold their value better and sell faster.

People like to see the neighborhood stay the same or get better. They know where they are going and what will stay.

The LHD process is important to the detailed consideration of proposals.

#### Janine Sheldon

Educated locally and spent some time in California. On return flabbergasted that we allow such change.

LHD preserves the neighborhood over a period of time, encourages better design and greater appeal.

Helps the environment and has positive economic impact, helping with business recruitment.

## Kim Childs

Have been here for over 20 years.

Some of the changes make me sick. People know this is a great area.

LHD will provide the protection based on local experience of the process.

Need to look out for the long haul. The opposition only in for the short haul.

# **Tracy Harty**

Definitions of preservation: - to keep up or intact.

Why is this important to our city – development from 1910 on.

The LHD is the only available tool.

The YCI provides little control.

Need to leave a legacy for those not yet born. We can update what we have and do so.

#### Virginia Lee

Support for the LHD proposal.

#### Jan Burton

Support for the LHD. The YCI did not work. Our neighborhood is beginning to be a hodge-podge. Everybody is aware

#### Susan Porter

Resident of 38 years. Not in support of LHD, although I have respect for those who do. Too restrictive. This proposal is not representative of the district which is concerned with 'teardowns'.

LHD would add much more restriction and limit the pool of properties and peoples investments. Proposals also too costly.

# **Jeff Justice**

Not in support of LHD – its an all or nothing approach.

There are great people on both sides and we need to cooperate.

I sell real estate. People have questions and they go away.

Not aware of any demolitions since temporary regulations were lifted.

#### Dave Gibson

Strong supporter of LHD. The LHD is a compromise. A larger YCI would not have the flexibility.

Any set of rules is a trade off. Property rights – a two way street.

# Virginia Hylton

Support LHD.

Only 15% of proposal on average go to HLC, and in 2010 only 6% so far.

Larger remodels should be reviewed.

Half the homes for sale are huge by neighborhood standards – way above the US average. Arguments about the negative effects of recent proposals ignore the fact that prices are decreasing state and nationwide.

#### Lisette Gibson

Support for LHD. We need the review of character-defining features.

This system is already in place. We also have 2,300 preservation districts across the nation. Original plats provided a diversity of houses and lots – for all. People move within the district. Neighborhood already meets the criteria to become a Nation Historic District. It will not stop the area in time.

#### Jim Pecshman

Opposed to LHD. Especially opposed to the inclusion of Sunnyside, with its ugly new power lines – they should have been buried, if the City is really concerned.

Question the accuracy of the survey.

Many homes have been tastefully remodeled. Concerns also on seismic issues – my field.

# **Aaron Murphy**

New to the neighborhood. Need to consider my and my neighbors needs. Opposed to this on a property rights issue. I have to look at a 2 story silver garage. My perspective could be as wonderful as yours.

LHD would be too restrictive.

#### Alison Dateman

I have lived here for 17 years. There are no silent people on this issue. Review of recent background. We need to get together to agree and work on the alternatives. It seems we can no longer compromise.

# McKay Edwards

A call for respect. Eople are here because the love it – and don't want to destroy it. Agree that this option is a tool, but it is a false choice.

We can use the YCl if modified – these are objective rules – you know what you get. We are moving towards subjective rules.

# Roger Little

Been here 50 years and love the neighborhood. It's the people who make it great. Saddened by people leaving or not wanting to be here. My survey of 250 revealed 70% support for modifying YCI & 70% opposed to LHD.

# Nathan Morgan

Strongly support LHD. Need to preserve the character of the area.

# Craig Harty

Support LHD.

Based on personal research the studies paint a very positive picture, inc: property values increase with LHD, LHD reduces flipping & move on speculators, promotes the neighborhood, longer residential tenure, and better economic market.

# **Craig DeMordaunt**

Opposed to LHD.

Suggest the use a voluntary design guideline tool. Education and teardown sessions for all, plus awards.

Better than regulations. Architects benefit from working with guidelines.

## **Scott Liddle**

The "For" is much more articulate.

What is historic is much more nuanced than what is attractive. Views may change – e.g Daybreak.

People increasingly want to live where there is character. Can only be created over a period of time. New build does not do this. Want to retain this for my family.

# **Ernie Voline**

Concerned with bureaucracy – self-perpetuating. Need a consensus to make even minor changes.

We can compromise.

## Mike Jones

Here since 1982. Real estate lawyer & Board of Adjustment chair.

LHD is the right thing and the only thing.

We need preservation and we need it now.

City is obligated to designate.

# Lyman King

Resident of 22 years. Opposed to LHD. Yet another layer of Government bureaucracy. Ned to work together to preserve integrity of neighborhood.

Economic vitality is served by new families coming into the district.

LHD will keep families out.

# **Annie Payne**

Support the LHD. Yalecrest Ave has development on all sides & working even at 11 pm at night.

Not so much a battle but a proving ground.

Battle is between big developers and me & I will use the tools available to me.

There is a world wide audience for \$2 million houses.

Look at history – Cistine Chapel was once on the chopping block. These are also works of art

Support LHD.

Demand for houses would go down, bringing more rentals.

We didn't buy with these restrictions. Map is too broad.
