

### What is the request? (Brief Project Description)

#### Volunteers of America (VOA) Detoxification Clinic - Conditional Use

Volunteers of America (VOA) is requesting Conditional Use approval for a new clinical detoxification/recovery facility to be located on the first floor in an existing building at 1875 S Redwood Road in the CC – Corridor Commercial zoning district. The proposed use will consist of a dorm style inpatient facility with 24-hour supervision, a commercial kitchen providing meals for clients, and counseling and medical services provided for up to 165 individuals staying at the facility. The use is classified as a Dwelling - Large Group Home and is allowed as a Conditional Use in the CC zoning district.

before a Public Hearing can be scheduled.

- A Public Hearing will be held for additional public comments and to make the final decision on the matter.
