2. Summary of each community coordinating group meeting:

GERALDINE E. KING RESOURCE CENTER

- February 13, 2020
 - o 6-month report:

Successes - Increased partnerships with neighbors as well as service providers. For example, the Huntsman Center came to provide medical screenings. Increased volunteers are assisting with meals, especially the SLC Arts Academy. Increase in bringing unsheltered folks into shelter, especially with the overflow shelter space available. Housing is always the focus. Case management is moving people towards housing, with 59 people moved into housing since the center's opening. Peer-support specialist recently started.

Challenges - Encampments in the nearby area. Loitering around the neighborhood. The mitigation and City team are working on issues around the neighborhood. Educating the broader community about homelessness remains a challenge that VOA is looking to tackle. Rhiannon asked how the business engagement process works. There have been frequent offers of help or services from people around the area. Zoe suggested that a meeting regarding partnerships and potential opportunities for guests of the HRC would be good to share ideas and collaborate on what things people are wanting to see.

- o Engagement Updates:
 - The Salt Lake City building improvement program has expanded, and no longer has income minimums. The amounts have also increased to \$1,500 for residents and \$3,000 for businesses. This funding is available on a first-come first serve basis. There is weekly yoga for HRC women on Wednesdays at 7. Zoe proposed that this be opened to the neighbors around the HRC as well, starting once a month. In the future, this program may be opened to more locations, including potentially a yoga studio or parks. Wasatch Community Gardens is partnering with Parks to implement a community garden at Richmond Park. WCG is interested in allocating garden parcels to the King Center/residents, if there is mutual interest. The time commitment would be 6 hours per week per plot (with the option to share between multiple people).
- o Problem-Solving:

communication within different groups.

Sapa Group received a license for a CDB Pharmacy nearby (at the old Bank of America property). There will be 24-hour security. Food Alley construction will begin soon. Sapa is also in the process for establishing a job-training program.

Although unrelated to the HRC, there has been camping in the area. Typically, groups have been moving between Library Square and Taufer Park. Rhiannon voiced concerns about transportation, food regulations, and encampment abatements. Zoe discussed the storage program available for anyone and will share information regarding this, and Kristina also discussed that transportation is being examined for long-term solutions. Action item: Cross-advertising at each of the Homeless Resource Centers regarding the Transitional Storage Program. There is a pilot program for low-income individuals for public transportation currently underway. VOA provides street outreach and casemanagement to unsheltered individuals. Hoang commented that there are a lot of efforts underway, but that things seem to be isolated. Salt Lake Valley Coalition to End Homelessness, which is comprised of different officials as well as individuals from the community, is regularly working to minimize gaps in the system and to increase



• May 14, 2020 -

Operator and County Level Update:

VOA - The Center has been screening every guest and working with Fourth Street Clinic to screen people for symptoms of COVID-19. VOA is using their own transport to get individuals who are potentially symptomatic to the correct resources. Some volunteers have been limited, but staff are open to volunteers as things get safer.

County – Testing is needed especially for individuals in congregate settings, the County has worked with the SLCo Health Department to be proactive to determine strategies to get people tested. So far, through testing events or these strategies, there have been 930 individuals who've been tested.

Stay Home, Stay Safe Motel Program: The County worked with operators to determine individuals who were likely to be more negatively impacted from Covid-19 (the criteria is: individuals over 60, individuals who have underlying health conditions, and individuals in both categories).

Quarantine and Isolation Facilities: There are facilities for people to safely self-isolate when diagnosed with Covid-19. There have been 480 individuals who have waited for results or have recovered from the disease.

o Engagement Team Updates:

One of the yoga teachers has offered to send links to yoga routines that she's recorded. The HRC security and landscape improvement grants, offered by SLC, still have some funding.

Law Enforcement Updates:

The Sacred Circle, east of the shelter has become a hot spot for loitering and activity. There is an upgraded security system there. Haong mentioned some security and safety concerns, especially around the Pharmacy around the corner. The pharmacy is also limiting the people inside, which leads to people outside congregating. The drive-through on the east side of the pharmacy will be activated, which likely means that parking on the east side of the building will be limited.

Problem Solving and Questions:

Salt Lake Arts Academy has started a construction project. The manager there has been allowing people to use picnic tables at school property. Law-enforcement has been helpful to set boundaries.

• August 13, 2020 –

Operator Updates:

Clients and VOA team celebrated the 1-year anniversary of the GEK. New housing programs have opened with Central City and Pamela's Place. Our COVID numbers are dropping. There is an increase of encampments in the area and Dennis and team are involved in working with them. 4th Street continues to test and the infection rate has remained low. There are cleaning procedures and mask mandates in the facility. There is now a full case management staff at the VOA, which will impact housing greatly. Hopefully 30 people will be housed by the end of September. Clients express that they have a lot of support from the team at GEK.

Shout out to the Sapa Group for being so supportive of the GEK programs and the parking spaces at their site.

Engagement Team Updates:



Allison Dupler is a new team member on the SLC HART team. She is filling Zoe's position.

Porta-potties have gone up in the ballpark area and should decrease the bio waste in the area. Feedback has been largely positive and the city will continue to re-evaluate what the porta-potties does to the area. The city council appropriated \$41,000 to a subsidize a program for bio waste clean-up on private property. This will allow property owners to request a clean-up on the SLC Mobile App for a fee of \$40. Advantage Services will provide the clean-up at \$80 and the city will cover half of it. The typical time frame for the clean-up could be 1 hour during business hours.

The city is aware of the unsheltered homeless and they are looking into ways to alleviate the issues the neighborhoods are seeing. Short term plan is to increase the presence of the cleaning crew, Advantage Services.

Law Enforcement Updates:

There is an influx of people experiencing homelessness in the 700 S area and other parts of the city are experiencing increased encampments. Is SLCPD putting up a camera at the 700 S and State St location? There are multiple requests to use the mobile camera city wide and Det. Murray will check on the status of getting one in the area. Sapa Group does not feel that there is more crime in the area but has seen an increase in camping and trash. The problems in the area are growing including the drug transaction. There are similar problems across the city but other areas have more violent crime and take precedence.

There is an uptick in property crimes in the district. Vandalism is up 200% and could be in response to the protest that have occurs. Assault is up, burglary and theft are up 30 case than last year. Stolen vehicles have gone up. A lot of this has to do with the protest but also the lack of bodies in law enforcement. The city works with the county to do camp abatements to clean large encampments. The city will look at programming efforts to close camps and provide resources to folks.

Life on State Project:

National organization that rehabs area to make them more walkable and community/business friendly. They will work on 600S to 900S in the future. They will plant more trees, slow traffic down, extend sidewalks, etc. UDOT will work with Life on State to complete this project.

Problem Solving and Questions:

Dennis will get more specific numbers on crime surrounding GEK. The Sapa Group would like provide gift cards to clients of the center who clean up the trash in the neighborhood. VOA staff is open to this idea and will provide a training to clients that would like to sign up on what to do if bio or needles are found. Employees from Dragonfly would like to coordinate this program and help with the clean-up. VOA is writing a best practice document on how this program should work.

November 12, 2020 -

Operator Updates:

More positive COVID-19 cases recently. VOA has been working closely with 4th Street clinic and the Salt Lake County Health Department to control the spread as much as possible. Intake has been paused occasionally to mitigate the risk of spread. Case Management team is working on new housing programs. VOA is overseeing one of the winter housing projects and about 50 individuals are in the program. This will run through the winter and into spring.



When there is a positive case in the facility, the individual will be moved to Q&I facility which is operate by the Salt Lake County Health Department. Additional testing events will happen after the case is found. Intakes will be paused to contain and limit the spread. When an individual has completed their quarantine period they can come back to the facility. Masks and required in the facility and sanitizing occurs frequently. Barriers like tarps will go between the beds to reduce the spread of COVID.

o Engagement Team Updates:

Community Commitment Program will close the 5th West area. The resource fair has been canceled. Hoang expressed concerns about the Sears camp, it has been elevated and it will get on the list for priority next week. The partnership with Sapa group has been great, the clean-up program has built trusts an accountability on both sides. The clients have been excited about the program. This program model is being proposed over at the Gail Miller Resource Center area.

CompStat report for the month of October was shared. Calls from the resource center went up slightly in October. Part 1 offenses went down a bit. Theft is a Part 1 offense due to severity or the frequency. This could even be stealing a candy bar from 7Eleven but the frequency of when this happens will put it in this category. Offenses 2 blocks from the center has dropped. Part 1 offenses 2 block from the center has gone up a bit but is trending down.

Hoang expressed that these numbers collectively are low for an urban area. Marcie expressed that the security team is doing a great job of keeping folks that are doing drugs or other crimes are away from the center.

Law Enforcement Updates:

CIU will increase drive bys in the area and will keep a close eye on the neighborhood. If there is a personal safety issue please call police.

Due to the overall strain on patrol team at SLCPD, the CIU will end and a new program will begin for community policy starting in January. There will be 3 divisions moving forward, Central, Pioneer and Liberty. Please continue to report what you see and use the online reporting system or SLC mobile app.

Residents would like additional education on when to call and not call SLCPD.

Problem Solving and Ouestions:

Who else from the community should be on this call? Neighbor, client, operator, school, community council chair, local business. Everyone has been invited but they were not able to be invited. We need to engage with folks again to get folks involved in this meeting. Hoang will reach to other members of the community. Life on State project will redevelop for 600 S to 900 S to start with. They are open to feedback on the look and design of this area. More lighting and pedestrian traffic in needed. The more eye and ears in this area will discourage the crime. Sears phase 1 project will start early 2021. In 3 years, there will be 400 doors within a mile radius of the resource center. If you have any ideas or suggestions about these projects please reach to Hoang.

GEK needs donations of blanket and pillows. Underwear, bras and socks are also needed and have to be in new conditions.

• January 14, 2021 –

o Operator Updates:

Salt Lake Temporary Winter Housing has opened and many have gone to the site. This has opened up space at the Geraldine E. King Resource Center. VOA received a CLIA waiver to do rapid COVID-19 testing onsite. Infection rate has been very low. Clients



that have tested positive are moved to the Q&I facility and additional testing will occur after a positive case is found in the center.

Staff is able to get vaccinated now that it has opened up to non-hospital health care workers. There are conversations to have 4th Street onsite to vaccinate clients at the resource centers once they are next. Thank you to SLVCEH on advocating for our centers to get vaccinated.

Partnership with Sapa Group to do cleaning around the neighborhood has been great. About 10 clients and employees will sign up to do this and Sapa will provide gift cards to everyone that participates. Bebita participates and likes to be involved in a project. It has been a successful and popular project.

o Engagement Team Updates:

CompStat report for the month of December was shown to the group. Calls for service has gone up. The large encampment near the center was cleared out and these calls may be correlated with that. Top calls included assisting another agency, theft, and 911 hang up. These are non-violent which is great. Part 1 offenses has dramatically decreased from last year. Part 2 offenses has had a little bit of increase since last year but overall, it has been trending down. Within 2 blocks of the center the calls have reduced and most likely due to the camps being cleared out. We will continue to keep an eye on all of this and will work with Det. Norgaard moving forward.

Camp abetments are continuing in the city. Some folks are moving to Camp Last Hope. SLC is aware of the camp by the center, next to boxing gym. Camp abatements will not happen for the next couple weeks due to SLCPD needing to do other things in the city. The SLC team is working on a camp prioritization document and looking at their proximity to vulnerable population. The document will hopefully be approved soon. The outreach teams are doing an incredible job and providing folks resources when camps are cleared out. The camp over by Sears has been cleaned up.

Law Enforcement Updates:

Det. Bob Norgaard has stated his new role as the Community Liaison Officer. He comes from patrol working with the Ballpark area. He will gather information from the community and work with partners like the resource center to solve issues and concerns. Co-responding will continue to happen and VOA is open to supporting these efforts. Police presence at the center has been very helpful. Salt Lake Arts Academy would like to invite Bob to tour their site so he can understand their needs now that classes will be in session. The previous support from SLCPD and Dennis has been great. The right option at the right time is needed for folks to get them to come inside. VOA

outreach will partner with SLCPD to engage folks at these encampments. There is a shuttle provided at the centers where folks can ride from 6AM to 1AM to get from center to center.

Problem Solving and Questions:

Bebita would like to see additional vegetarian options at the center. Her experience has been positive and case management and 4th Street has been helping her.

88 people were housed last year form the center.

Katy is grateful for the support over the last few months and excited to hear about the shuttle system. She will share this information with the community. Katy will reach out to Tessa from the Maven Group to see if she would like to join our Neighborhood Advisory Council.

The SLVCEH primary goal will be to restore housing affordability during the legislative session.



GAIL MILLER RESOURCE CENTER

• February 12, 2020 –

o 6-month report:

Challenges - The biggest challenge is transitioning people from the HRC into housing. Another challenge is the abandoned house in front of the HRC. There were upwards of 20 people going to and from that house during a one-hour period last week. City Civil Enforcement and SLCPD visited last week, and the owner has since torn down the shed that was a hotspot for activity.

There are some guests that are violent being dropped off by the police to the center. There was an incident last week, where someone returned to Alpha Munitions and threatened staff with a knife. The individual was not arrested. Bob regularly collects paraphernalia and weapons from around his property, as people are often leaving their weapons in spaces outside of the HRC or have weapons on their person in spaces that aren't covered by total body searches. Neighbors are concerned with safety in the neighborhood. In previous conversations, SLCPD has discussed that they didn't receive funding for additional law-enforcement so there haven't been opportunities for additional patrolling.

Successes - Despite lacking housing, there are jobs available. There is a monthly job fair with many businesses in the area connecting to clients. Amy R. has taken note of a positive environment inside of the HRC, which goes along with certain measures and programs (the town halls available for residents, for example).

Alan has noticed that sometimes meals are off schedule (breakfast for lunch for example).

Future - Catholic Community Services will not be operating the Gail Miller Resource Center past this year. The Shelter the Homeless board has had two groups approach who are interested in running the center and will be deciding soon so that the transition can begin.

Engagement Team update:

The City removed income requirements for residents and businesses doing landscape and security improvements. Also, the amounts for each have been raised to \$1,500 for residents and \$3,000 for business owners.

Problem Solving and Questions:

Amy R. will be sharing information regarding the safety issues with the STH board to pursue funding for lighting options. Wasatch Front Regional Council is investing in a study regarding neighborhood improvements. Amy H. also suggested that this information be shared with decision-makers.

• May 13, 2020 –

o Operator updates:

Protocols have been shifted to mitigate issues around Coronavirus. There have been around 200 tests and only 3 positives in the center. Staff and residents are being screened which has been successful in mitigating things. For the next three-four weeks, there will be regular testing (multiple times a week). Salt Lake County also been providing locations for individuals who need a place to self-isolate and quarantine. The County is also sending out safety advisors to each resource center to help mitigate and prevent the spread of Covid-19. The County has also created special outreach teams, which pair outreach staff with a public health nurse, to help with prevention and information around



Covid-19. Alan is currently at one of the motels. He has questions regarding the process so far. The Mitigation team will be following up with Alan to learn more about his situation. Any individuals in the Stay Safe, Stay Home Motel are receiving meals.

- Engagement team updates: There is still some money available in the landscape and security grant from Salt Lake City. There has been increased cleaning around the Gail Miller Resource Center. This is happening around the sidewalk in front of the Miller Resource Center as well as on High Avenue. Any feedback on the clean-up can be directed towards Zoe. SLCPD put up a police camera in front of the Gail Miller.
- Law-enforcement updates:
 There have also been increased reports of cars on Paramount Avenue. Currently, City
 Parking Enforcement isn't citing for time-restrictions, but is for cars that are a public
 safety hazard. Some of the cars on the street have been cited as they meet this criterion.
 - **Problem Solving and Ouestions:** Zoe's position has not yet been filled or had funding announced, she will be leaving in August. The new operator for the center has not been announced but will be one of the existing operators (The Road Home or Volunteers of America). Currently, the SLCo Health Department is not abating encampments under 10 people. Amy H. is concerned about congregating locations, especially groups gathering at the 7/11 on 1300 S. She has been working with the Maverick district manager to find information regarding how they've made that location safer. Amy is considering getting the Volunteer Corps involved. Detective Bishop will check into their current status and thinks that they may not be effective or able to help in that area. Matt has noticed that many in the group at the 7/11 are not from the Miller Resource Center. SLCPD has an intranet service to create hotspots and make notes to check on certain areas. When things elevate, things are made into an Operation discussion for a specific targeted effort. This hasn't happened yet, but Det. Bishop reached out to Det. King to get this process started. Matt asked if it would be possible to drop off a police camera in that area, and Det. Bishop said that it's possible once another location has one removed. Shelley has noticed a lot of trash around the neighborhood. Action item: Zoe will follow up about Advantage Service's Clean Team efforts in the Ballpark Area.
- August 19, 2020 Summary unavailable due to staffing changes at Shelter the Homeless, but meeting was conducted in accordance with CUP requirements

November 18, 2020 –

- Updates from Operator:
 - The Road Home has taken over as operator for Gail Miller Resource Center; Michelle Flynn (TRH Executive Director) and Sarah Strang (TRH Deputy Director of Crisis Services) will support Matt and team. Admin has been working closely with SLCo Health Department to follow Covid-19 guidelines, as well as weekly on-site testing through 4th Street Clinic. GMRC celebrated their one-year anniversary, and shared highlights including housing and job placement data.
- Updates from Engagement Team:
 CompStat report from October shows a decline in calls for the area. A comparison from last year shows an increase in Part 1 offenses, however this report includes petty theft from local stores like Walmart. The pandemic has greatly contributed to the problems the community is seeing in the area. Small changes, such as public bathrooms closing and the



jails limiting capacity, compound issues of homelessness in each neighborhood. Affordable housing has not come along as quickly as expected to solve our city's homeless crisis. Neighbors suggested inviting the Housing Authority to these community meetings. There's a camp behind Challenger School that is going to be addressed by the Community Engagement team this week.

o Law Enforcement Updates:

CIU is being restructured, and detectives will be returning to patrol. Salt Lake will be broken up into three areas to assist in addressing high call volumes with more officers on the street responding. Neighbors are concerned by a 55% increase in violent crime, and poor responses from responding officers. Detective King encourages the community to continue calling and reporting crimes, so they can track and respond to trends.

O Problem Solving and Questions:
Community Engagement team is looking for businesses to partner with HRCs to do cleanup in the area. Volunteer opportunities are still available to serve dinner and sort donations. TRH has a Turkey box program as well as Crossroads Urban Center.

• January 21, 2021 –

Operator Updates

The Road Home partners with 4th Street Clinic to do weekly Covid-19 testing. If a guest tests positive, they will be directed to a quarantine and isolation facility. Vaccinations for staff have begun through the SLCo Health Department. Bed utilization rate is at 100% capacity to meet the needs of the community, and those who can't stay at the Gail Miller will be referred to Temporary Winter Housing or another Homeless Resource Center.

o Engagement Team Updates

The area has a new SLCPD Community Liaison Officer, Officer Meinzer. The Engagement Team is working to address camps and are prioritizing those that are near schools or other vulnerable populations. The City Source app is available for community members to report issues in their community, such as graffiti and shopping carts. Comp Stat report reflects an increase in calls for December and November, however those numbers are down from previous months.

The NAC meeting will change to 5PM to accommodate Office Meinzer schedule.

Law Enforcement Updates

SLCPD Officer Meinzer has joined the area and would like to work with community members to hear their opinions and problem solve. Kelly from Lux Bakery would like more resources for folks who are homeless in the area. Officer Meinzer would like to deploy the bike squad to work with the community. Council approved additional officers to be hired, who will be able to assist in the area.

Problem Solving and Questions

Jim Grisley is a business owner in the area, and is having issues regarding trespassing, assault, and drug use. There's a scheduled meeting with the Community Liaison Officer to address these issues.

The abandoned house in front of the HRC is under contract but hasn't been sold yet. The property owner doesn't have the financial means to demolish the building, however additional resources could facilitate this; grants may be available if crime is high and/or the city can demolish the building then charge the owner in the form of a lien on the property.

HRC resident, Alan expressed that COVID-19 is an issue as well as loitering.





Council member Mano suggested supporting a resolution to designate a camping area for those who are sleeping outside. The issue is nuanced, and will be discussed further with Community Engagement Team, but Jim Grisely supports taking action to resolve the issue of folks not having somewhere to go, and Officer Meinzer would support the outcome with additional measures that address safety and hygiene. It appears there are more individuals sleeping outside due to COVID-19 plus additional camping resources, such as excess tents.
