2. Summary of each community coordinating group meeting:

GERALDINE E. KING RESOURCE CENTER (GEK)

• March 11, 2021 -

Service Provider Updates:

Covid-19 vaccinations are provided at GEK, totaling 70 residents and a majority of staff who are vaccinated. Case managers are connecting residents to any available housing vouchers that have come available. Residents created a PowerPoint presentation to propose a gardening project at the facility. They would like to plant flowers and vegetables in open bed space to create a sense of community connection with the women at the center.

- Calls at GEK have decreased due to better coordination with center and SLCPD to determine which calls need a response or could be resolved in other ways. Most calls have included trespassing, intoxication, and vehicle break-ins. Adjacent owner has installed a "No Trespassing" sign, so SLCPD can enforce no camping/loitering in the area. Allison recommended to Civil Enforcement to fence off the driveway area to the west to decrease camping.
- Problem Solving and Questions:
 Hoang is continuing to engage with residents and the HEART team for a neighborhood trash cleanup with gift cards provided to participants by Dragonfly. The neighboring office building has hired fulltime staff to pick up excess trash. Biowaste is also frequently found in the parking garage. Residents at GEK suggest implementing a porta potty-like system for the unsheltered to decrease biowaste. Residents would like access to Wi-Fi in the facility, and GEK is working with their IT team to assess feasibility.

• May 13, 2021 -

Service Provider Updates:

Rapid testing is provided onsite by VOA and 4th Street Clinic and the SLCo Health Department are administering vaccinations. Residents suggest providing a referral benefit to help their friends get vaccinated.

Tracy Aviary met with VOA, STH, and the HEART team to discuss the community garden proposal that was discussed in the previous meeting. Shelter the Homeless is partnering with the Salt Lake City Arts Council to install a mural in the courtyard this summer.

Residents are concerned for their safety around the facility. Unsheltered individuals are lingering outside of the GEK, blocking the sidewalk, and intimidating residents.

o Engagement Team & Law Enforcement Updates:

The Health Department is providing "No Camping" signs that local PD will be able to enforce. SLC and SLCPD are working together to abate the encampment outside of the center. Residents suggest creating an area for camping that's maintained for individuals to congregate with services and away from current areas where there are issues. SLC is supporting a Tiny Home Village that should assist unsheltered individuals by next March and is also aware of requests for sanctioned camping.

Residents are concerned about a drone that has been spotted flying in the courtyard several times. The women are concerned about their privacy and safety. It's confirmed that this drone has a camera attached to it and is flying near the second floor.



• September 9, 2021 –

Service Provider Updates:

Kallie McKown is the new Director of GEK and has worked at GMRC and MRC previously. Three guests have tested positive for Covid over the last month, and contract tracing is taking place to minimize the spread. GEK is continuing to implement mask policies and coordinate with 4th Street Clinic for vaccinations.

The courtyard mural is completed in partnership with Shelter the Homeless and SLC Arts Council. Residents have been working with staff to move the garden project along, and vegetables are being utilized in meals.

Engagement Team & Law Enforcement Updates:
 Crime statistics have decreased over the last few months. Det. Meinzer attributes this to increased presence in the area. The majority of calls in the area around the GEK are related to transient problems, likely those who are unsheltered.

Problem Solving and Questions:

Ted has seen an increase in biowaste and trash near his business and believes the crime stats don't capture what he's seeing. Det. Meinzer recommends reporting these types of issues on the SLC Mobile app as well as reporting to dispatch. This approach will not only address the current problem but will help to allocate additional resources to the area. The HEART team has worked to identify areas of special concern to prioritize responsiveness from the SLC Mobile app.

Andrew has installed boulders on his property's park strip to decrease camping and loitering, however the city is concerned about the lack of greenspace. Dennis will connect with Andrew to discuss further.

Camping near the tree on the park strip has been a concern for the residents and neighbors. Shelter the Homeless is installing flood lights on the facility to increase lighting, and also installing landscape design to decrease the available space for loitering. VOA, security, SLC, and police have been coordinating to keep that area clear.

• November 18, 2021 -

Service Provider Updates:

Staff is trained and conducts rapid Covid tests to keep infections low. The vaccination rate is 30% and incentives are provided to residents. Housing placements are lower than the previous year due to Covid. The area of concern outside the GEK that was addressed in the previous meeting has been mitigated to create a safer area. Flood lights, landscaping, and coordinating with security and law enforcement have proved to be a successful strategy. Candy Cane Corner is accepting donations of toys and Christmas items for families experiencing homelessness during the holidays.

Engagement Team & Law Enforcement Updates:
 SLC is working on a 24-hour parking ordinance to decrease those camping in RVs and vehicles. In the meantime, outreach teams are working to connect them to resources.
 Biowaste and excess trash should be reported on the SLC Mobile app.
 Det. Meinzer advocated for overtime shifts to be allocated near the HRC to be proactive in the area. This has caused calls for service to decrease because officers are onsite mitigating issues before it becomes a concern for neighbors.





o Problem Solving and Questions:

Tony is a neighbor and is frustrated by the landscaping mitigation efforts outside of the GEK because it has pushed loitering to other parts of the area, namely outside his apartment complex.

David Clark wants to know what resources are being provided to individuals who are homeless and are seemingly unproductive. Inside the GEK, housing is the primary goal and minimizing barriers to obtaining housing or employment. Outside the GEK, outreach teams are connecting with those individuals to connect them to resources. Resources can include connection to substance use treatment or an ID.

Janelle is concerned about good Samaritans bringing food and supplies to unsheltered individuals, who create an immense amount of trash and waste. Biowaste is also a frequent concern and is under the impression that the city will not clean this up because it's on private property. SLC clarified that private property will be cleaned up if reported on the SLC Mobile app.



GAIL MILLER RESOURCE CENTER (GMRC)

• March 17, 2021 –

o Service Provider Updates:

The Road Home coordinates with 4th Street Clinic to conduct weekly Covid-19 testing. If a resident tests positive, they are taken to one of the County's facilities for two weeks to quarantine and recover. There are additional rooms set aside at GMRC for residents with symptoms to quarantine while they wait for a test. In total, 102 vaccinations have been given at GMRC, 67 of those are residents and 35 are staff. GMRC's capacity is operating at 95-100% occupancy, and staff is coordinating with other HRCs to place residents into shelter. Winter overflow shelters will close on April 14th, which will increase the need for immediate affordable housing to assist with the lack of capacity systemwide. There are additional funds that may be able to assist with homeless services but would be best put toward a permanent solution to the seasonal increase of those experiencing homelessness. Construction will begin this summer on 300 West. The project will take approximately two years and will have impacts on traffic and businesses.

Two bills are of note in the current legislative session. H.B. 347 focuses on the structure and governance of homeless services, namely a state homeless coordinator as well as a council that will report to the governor and improve local coordination. Additionally, \$50 million will be made available to affordable housing and homeless services; \$25 million will preserve existing affordable housing, \$10 million will build new affordable housing, and \$15 million will go toward homeless services that will be matched by philanthropic community.

• Engagement Team & Law Enforcement Updates:

The abandoned building on 238 Paramount has not yet been demolished, and there are currently no updates on a timeframe for completion. A demolish ordinance cannot move forward until there's a building permit for the site.

Shopping carts will be removed by Romax 2-3 times per week and should be reported on the SLC Mobile app. Walmart isn't engaged in coordinating the return of their carts. Det. Meinzer meets every other week with Matt Melville at GMRC and has confirmed that appropriate action is taken when drugs are found within the Resource Center. Crime reports are down from this point last year, and a new online reporting system will be implemented so officers can stay out in the community.

Problem Solving and Questions:

A camp on the west side of 300 West has been causing issues for local businesses. The upcoming city project on that street is hopeful to alleviate those issues and improve lighting along the street.

Zoning is proposed for an SRO, although Ballpark residents are not supportive. Neighbors and businesses feel that the Ballpark community is doing their part to provide services and would like other areas to contribute more.

• May 19, 2021 -

Service Provider Updates:

To contain the spread of Covid-19, residents are continually asked to wear masks and social distance in addition to onsite rapid testing. This week one resident was positive and sent to a quarantine facility. 34% of residents are vaccinated, which is slightly above the rate of general the population. YTD, 61 individuals have entered into a positive housing



exit, and residents are finding employment with businesses in the area. On any given night, the capacity is at least 95% full, most heavily utilized by men.

Engagement Team & Law Enforcement Updates:
The engagement team has been meeting with local businesses and hearing concerns of camping. There was an abatement of a camp near Lowe's that has dispersed camping. The construction on 300 West has begun and causing significant barriers to access the facility. There will be one lane of traffic in each direction, which has caused delays. The construction will additionally cause a decreased police presence because officers will be avoiding the traffic as well as a delay in response time for emergency services. The top five calls for service include 9-1-1 hang-ups, transient problems, domestic violence, suspicious circumstance, and emergency assistance.

Problem Solving and Questions:
The abandoned building at 238 Paramount was demolished to decrease unwanted activities. Jim Grisley has seen more trash and jaywalking lately, and will install an additional trash can outside. A "No Parking" sign was destroyed and needs to be reported on SLC Mobile app for replacement.

• September 22, 2021 –

Service Provider Updates:

Covid-19 protocols and testing are still in place, with a continued coordination with quarantine for positive cases. Vaccination rates within the facility are trending higher than SLCo general population. Capacity within the facility averages 95% full each night, making available beds difficult to connect to for unsheltered individuals. The Road Home has been preparing to move individuals into the Magnolia apartments owned by Shelter the Homeless and providing move out kits to assist their transition.

Matthew Melville with be stepping down an Director of GMRC and leaving The Road Home.

o Engagement Team & Law Enforcement Updates:

Det. Meinzer has been working the GMRC to understand crime statistics in an effort to deter incidents. Crime reports peaked in June, however an increased presence decreased incidents by August. Officers have been helpful in deescalating mental health crises at GMRC. New officers have begun training to supplement the 16% decrease in the force. The engagement team has been working on a pilot a program to assist RVs in repairs to become mobile to decrease camping. Funding is available to improve public façades in the neighborhood.

Problem Solving and Questions:

The SLC Mobile app should be utilized to report camping, biohazards, and shopping carts. City Council is considering a budget amendment to fund an expansion to the Downtown Ambassadors program as an approach to mitigation.

Bod Danielson is concerned with the lack of resources for individuals with mental health and substance use disorders. The Huntsman Center has broken ground on a mental health receiving center. Connecting individuals to resources is difficult, however GMRC is working with First Step House to offer resources within the center.

o 300 West Project:

This is the largest street project SLC has undertaken, which has involved continued engagement with local businesses and neighbors. A new sidewalk in complete and



underground utilities are being replaced. Gift certificates will be given to transient individuals resistant to moving along and impeding construction efforts. Emergency services will coordinate with construction managers to decrease response times seen because of the road work.

• December 1, 2021 -

- Service Provider Updates:
 - Mike Young is the new Director of GMRC, formerly the Director of the Men's Resource Center. Rapid Covid-19 tests, vaccinations, and flu shots are offered to residents. The bed capacity averages 97% full each night, and 20 individuals moved from shelter into housing in the last month.
- o Engagement Team & Law Enforcement Updates:
 - Neighbors are encouraged to continue reporting issues on the SLC Mobile because it helps the city allocate resource to the area. SLC has undertaken a pilot program to address car camping and RVs to get vehicles in working condition. The expansion of the Downtown Ambassadors program is being finalized and will roll out soon.
 - Police presence in the area has increased to be proactive in the neighborhood to decrease calls for service. This presence has mainly been addressing an increase in drug crimes. The top five calls for service were transient related, unwanted persons, 9-1-1 hang-ups, medical assist, and theft investigations.
- o Problem Solving and Questions:
 - Jim Grisley would like to know what resources are being allocated to housed neighbors and businesses. The façade grant was made available to the local business, which was utilized by Jim's business, and the city is increasing lighting and no parking areas near GMRC. The issues seen in the surrounding area would be best resolved by creating affordable housing. Jim would like to discuss moving the GMRC to another area to decrease the issues of drug use he sees outside his business.
