

# **Expedited Permit Review**

### What is an Expedited Permit Review?

The Expedited Permit Review process is a means to accelerate an <u>initial</u> plan review by a qualified third party with significant experience conducting building plan reviews, as selected and approved by the building official. The entity conducting the Expedited Plan Review shall provide <u>initial</u> comments, including corrections to be made to the construction documents, within ten (10) business days of the date the application was filed.

The success of this approach depends on the type and number of corrections required for second or multiple reviews beyond the initial review, where only the initial review is expedited. Subsequent reviews following the initial review are completed in a timely manner and are reviewed in the order in which they are received by the applicable Plans Examiner(s).

#### How much does it cost?

Expedited Permit Review fees shall be two (2) times the standard review fee as set forth in Section 18.32.035 of the Municipal Code. The fee is due at the time of application with the Building Services Division.

### **Application:**

Acceptance of an Expedited Permit Review is accomplished through the signing of the Expedited Permit Review Form and payment of the fee. The Expedited Permit Review form may be completed on the reverse side of this form.

The expedited building plan review may be conducted by a qualified third party with significant experience conducting building plan reviews, as selected ar approved by the building official. The person(s) assigned to conduct the expedited building plan review shall provide initial comments, including corrections to be made to the building plans, within ten (10) business days of the date the application was filed.  Only an initial (or first) review of a project is subject to the expedited process. Subsequent review of the same project are subject to the regular review queue.  All expedited building construction documents shall be submitted electronically.  Fees to expedite building plan reviews shall be two (2) times the standard building plan review f	n vs
