## Fireworks Stand Worksheet

### Fireworks stand criteria

- 1 Area around the stand or trailer shall be kept free & clear of all weeds, debris and other flammable materials for a distance of 25 feet in all directions.
  - 2 Stand or trailer shall not be located in a way to eliminate the off-street parking requirements required by the zoning ordinance.
  - 3 Site triangle must be preserved and the trailer may not be located in the public way.
  - 4 Stand and/or trailer shall be located in accordance with the applicable zoning ordinances.
  - 5 50 foot radius - no smoking, no fireworks discharge. This must be posted on signs.
  - 6 License and permits must be posted.
  - 7 Minimum 2A-10BC fire extinguisher required.
  - 8 Trailer and stand must NOT BE IN PLACE before five (5) days before sales time or five (5) days after the sales end.
  - 9 Electrical must comply with code.
  - 10 Must be locked up at night or when not operating.
  - 11 No sleeping inside stand or trailer.
  - 12 All personnel must be at least 16 years old.
  - 13 Stand or trailer may not be located closer than 50 ft to any LP gas or gasoline storage and/or dispensing device.
  - 14 No sales to persons under 16 years of age without guardian or parent present.
  - 15 Signs showing legal dates of sales and discharge must be posted.
  - 16 Loose powder is to be cleaned up quickly.
- A All applications for fireworks stands must include three (3) site plans detailing the above mentioned criteria. One for permit files, one for business licensing files and one for the applicant.
  - B The application must identify whether tents are planned.
  - C The application must identify the size of the stand, trailer or tent. Tents over, 400 square foot in size and canopies over 400 square feet, must have Fire Department approval.
  - D A permit fee of \$99.00 + Temporary Use fee of \$329.00 for each stand will be required.
  - E A \$200 cash bond must be posted with Building Services
  - F Proof of insurance must be shown.
  - G The necessary business licenses must be obtained.
  - H Once the fireworks stand is in place, you must call for an inspection of the location and other criteria.
  - I When the sales period is over, call 801-535-7224 to schedule a final inspection.
  - J After obtaining a final inspection, complete the [Refund Request Form](#) to have the bond refunded.

I acknowledge that if I do not abide by the conditions and standards for an outdoors fireworks stand, my business license may be revoked.
