### Furnaces, make-up air burners:

Up to and including 200,000 BTU:	\$29.00 ea.
Over 200,000 and up to 300,000 BTU:	\$41.00 ea.
Over 300,000; up to and over 1,000,000 BTU:	\$65.00 ea.
Each additional 500,000 BTU or part thereof:	\$23.00 ea.

### Installation/Relocation of each floor furnace, including vent:

\$18.00 ea.

### Installation/Relocation of each suspended, recessed wall or floor mounted unit heaters:

Up to and including 200,000 BTU:	\$23.00 ea.
Over 200,000 and up to 300,000 BTU:	\$41.00 ea.
Over 300,000 BTU:	\$65.00 ea.

### Installation/Relocation/Replacement of each appliance vent installed and not included on an appliance:

\$18.00 ea.

### Repair/Alteration/Addition to each heating appliance, refrigeration, cooling, absorption, or evaporating unit/system (including ductwork):

Up to a \$1,000.00 contract value:	\$41.00
Greater than a \$1,000.00 contract value:	\$100.00

### Installation/Relocation of each boiler/compressor up to and including 3 h.p. or each absorption system up to 200,000 BTU:

\$29.00 ea.

### Installation/Relocation of boilers:

Over 200,000 and up to 300,000 BTU:	\$41.00 ea.
Over 300,000 and up to 1,000,000 BTU:	\$65.00 ea.
Over 1,000,000 and up to and over 2,000,000 BTU:	\$100.00 ea.
Each additional 500,000 BTU or part thereof:	\$17.00 ea.

### Air Handling Unit:

Up to and including 10,000 cfm, including ducts attached thereto:	\$29.00 ea.
Over 10,000 cfm:	\$65.00 ea.

### Evaporative cooler other than portable type:

Up to 65,500 cfm:	\$23.00 ea.
More than 6,500 cfm:	\$65.00 ea.

### Ventilation fan connected to a single duct:

\$18.00 ea.

### Ventilation system not a portion of any heating/air conditioning system:

\$18.00 ea.

### Installation of each hood which is served by mechanical exhaust including ducts for each unit:

\$41.00 ea.

### Installation/Relocation of domestic type incinerators:

\$23.00 ea.

### Installation/Relocation of Commercial/Industrial type incinerator:

\$65.00 ea.

### Each appliance or piece of equipment not classed in other appliance categories, or for which no other fee is listed (i.e. gas-line, fireplace, stove etc.):

\$23.00 ea.

### Installation/Relocation of cooling towers:

1 1/2 h.p. up to and including 4 h.p. or tons:	\$29.00 ea.
4 1/2 h.p. up to and including 10 h.p. or tons:	\$40.00 ea.
11 h.p. or tons and over:	\$76.00 ea.

### Installation/Relocation of compressor or absorption systems (including chillers, AC's, heat pumps, refrigeration units:

1 1/2 h.p. up to and including 4 h.p. or tons:	\$23.00 ea.
4 h.p. up to and including 5 h.p. or tons:	\$27.00 ea.
5 h.p. up to and including 6 h.p. or tons:	\$35.00 ea.
6 h.p. up to and including 7 h.p. or tons:	\$39.00 ea.
7 h.p. up to and including 8 h.p. or tons:	\$43.00 ea.
8 h.p. up to and including 9 h.p. or tons:	\$47.00 ea.
9 h.p. up to and including 10 h.p. or tons:	\$53.00 ea.
Each additional h.p. or tons above 10 h.p.:	\$4.00 ea.

All Mechanical Permits have a base fee of \$57, plus the total of the above chart and a 1% State Fee.
