- RE: Deliberative Community Engagement with Downtown Business Leaders on Salt Lake City Critical Needs and Funding

Summary

At the request of Salt Lake City, the Kem C. Gardner Policy Institute convened and facilitated a discussion with select city business leaders to solicit feedback on the city's proposal to fund critical infrastructure, housing and public safety needs. This technical memo provides a high-level summary of the theme and findings from this convening.

We utilized a process known as Deliberate Community Engagement to engage these business leaders. The process connects people with a variety of perspectives, provides them with a foundation of high quality information, and enables them to share perspectives that will lead to informed decisions.

Fifteen business leaders attended the deliberative session on April 10, 2018 at the Gardner Policy Institute. Discontent with the city's public input process emerged as the dominant theme. Specific feedback was given on the four critical needs and proposed funding mechanisms. Each of these is discussed below.

Discontent with Public Input Process

The primary theme from the discussion was discontent with the input process and that feedback was being sought about a plan that had already been decided. One participant described it as an announcement rather than an agreement. "There's not going to be the level of engagement that the city wants if it continues to be an announcement rather than an agreement." Others expressed concern that while their industry would be directly affected by the sales tax in particular, they learned about the proposed plan indirectly rather than being approached by the city as a key stakeholder in the issue.

The needs identified are of importance to this group as well, and they would have liked to have been involved in the problem-solving process. They wondered how much their input could be incorporated if input is being sought a week before the vote. "It seems like a sales job rather than a public process."

In this same vein, it was expressed that more time is needed for this input process, and that an issue as complex as raising and spending additional revenue requires a more thoughtful, transparent dialogue.

Those who had recently heard from a city representative tasked to inform and solicit feedback from the business community expressed that the representative did not have sufficient information. Or, it was assumed sufficient detail of these plans must not exist.

Participants said the lack of communication and transparency is not a new characteristic of the city's policy process. However, this perception can be altered by using feedback from this discussion as a way to improve future public policy deliberations. Another way to improve this public policy process is greater transparency, particularly regarding why new revenue streams are necessary rather than more efficient budgeting. The example cited is the mismanagement of road maintenance. Participants opined that road conditions got this bad due to budget mismanagement. There were concerns mismanagement would continue to happen with any new revenue stream.

Feedback on Critical Needs

The group agreed the four needs identified by the city are indeed critical, and that these needs have existed for some time. Homelessness was also brought up as critical need. They acknowledged two of the four needs seek to address aspects of homelessness, but concerns were raised that more police and affordable housing wouldn't sufficiently address this issue; police officers lack authority of the law to dissuade loitering and camping, and transitional housing isn't transitional for those who suffer from mental illness. Some worry the perceived lack of safety may start to affect their ability to recruit talent from out of state. The increase in Medicaid funding helps, but they wonder if it is enough to address the complex issue.

More generally, it was recommended that more specific plans with prioritized recommendations should be made available. For example, when \$5 million is being requested for housing when \$20 million is needed, what aspect is prioritized for that \$5 million and why?

It should be noted that some participants were familiar with the city's plans and recommendations, and others appeared not to know the city had conducted in-depth studies and plans altogether.

Feedback on Funding Mechanisms

Most of the discussion focused on the proposed sales tax. Participants seemed more open to the General Obligation Bond as the decision lies with voters with adequate time for feedback.

Concern with the sales tax mostly focused on its economic impact. Participants shared concerns that a sales tax increase would slow economic growth and impair economic competitiveness. They said the quick turnaround of the sales tax vote on April 17th would deter thoughtful dialog necessary for such an impactful decision, especially given the perceived lack of detailed information provided and lack of community engagement. For example, it was not communicated with the commercial community how the revenue mechanisms would affect their properties. The only information provided to the public is how much it would cost a household. Some noticed the city had involved their constituents in the process while "neglecting the economic engine, the business community."

It was recommended that the city convey funding mechanisms that have been tried but unsuccessful. This disclosure would help the public better understand how the city has come to the conclusion that a sales tax increase is the best option.

Additional concerns expressed include the following:

- \$67 million of state funding for Operation Rio Grande expires in 2019
- Overall tax rate if county transit tax is approved
- Why \$3 million is set aside for a rainy-day fund when the needs are so critical, especially since rainy-day funds can be used for unspecified needs

Some in the group believe that adequate funding already exists, but that finding efficiencies in the current city budget hasn't been prioritized. There was little feedback when pressed for alternate funding recommendations, but the following options were offered:

- Increasing density development to increase the tax base
- Considering state change to provide road funding based on square footage rather than linear foot

Methodology

Leadership from 24 companies around the city were invited to participate in the roundtable discussion. The list was generated jointly by Wilkinson Ferrari and the Gardner Policy Institute. Of the 24 invited, 15 attended. With the given time frame, the Gardner Policy Institute was able to allow invitees a two-week notice, and ensured a brief meeting given their busy schedules. Invitations were mailed to each recipient by the Gardner Policy Institute director. Follow-up phone calls were made to those who had not responded. Confidentiality was of particular concern to multiple invitees and so the deliberation included only Gardner Policy Institute staff.

Using information provided by Wilkinson Ferrari, the Gardner Policy Institute created a "placemat" fact sheet for the discussion outlining details and action plans for the four critical needs, and the two revenue generating mechanisms proposed to fund the action plans. Each participant was given time to review the fact sheet before discussion began.

Given the short duration of the conversation, the Gardner Policy Institute was able to collect a wide range of input, but did not have sufficient time to probe for feedback on each issue. This memo represents the general consensus as it was expressed during this hour. For each topic, there may have been some participants with viewpoints who chose not to share their perspectives.

Before we moved in August of 2016, there were a few neglected roads (2700 South between 2000 East to 1300 East, for example). It seems the adding of bike lanes on many roads has been a priority of this administration rather than responsible maintenance of well-used streets. I implore the city administration make it a high priority to lay down new asphalt and not do the haphazard patching on street surfaces and keep Salt Lake the beautiful, clean, well-maintained city it has been!

Perhaps all the workers that are involved in servicing the area generally can communicate the needs better (landscape crews, street sweepers, construction inspectors, garbage collectors)? The newly replaced stamped concrete at 1900 East and 1300 is cute, but taking care of existing deferred maintenance and basic servicing is important. Yet the city is proposing another round of tax increases. While housing prices, rents, and the cost of living continues to outpace wage increases in Salt Lake City, now is not the time to raise taxes again on the citizens of Salt Lake City, who are already strapped for cash and fighting to make ends meet. Below is a list of some of tax increases that affected taxpayers across the state, taxpayers in Salt Lake County, and taxpayers in Salt Lake City in recent years. In 2015, a state property tax increase of 3% was passed that was used to equalize the spending of property tax revenue (SB97). Under SB97, every homeowner in the state saw a tax increase, but the \$75 million collected was distributed only to school districts that fell below a set funding threshold. Effective January 1, 2016 the state of Utah raised gas taxes by 5 cents with annual increases indexed to the price of gasoline thereafter (HB362). In 2017, the state of Utah assessed taxes on all purchases made on Amazon. In 2018, the state legislature raised fees and taxes. At the Salt Lake City we have seen property tax increases in 2010 by roughly \$100 per homeowner and again in 2013 by approximately \$59 per homeowner. And at the city level, we have seen property tax increases in 2013 by approximately \$67 per homeowner, and in 2017 by roughly \$20 per homeowner. Such and 2019, this equates to 10 and 15 percent in those years. Moreover the public utilities also increased the cost of water 5 percent this year alone. And now in 2018, Salt Lake City wants to increase tax slop a half a percent and property taxes yet again. Every time a time increase is proposed it is meant to be the panacea to a problem but yet rarely goes away but leads to more and more unfulfilled promises. Living along the Wasatch front is becoming less affordable and increased fees and taxes do little to help struggli

		As citizens of Salt Lake City, we are subject to city taxes, Salt Lake County taxes, and Utah state taxes and in recent years we have seen tax increases at all three levels. Yet the city is proposing another round of tax increases. While housing prices, rents, and the cost of living continues to outpace wage increases in Salt Lake City, now is not the time to raise taxes again on the citizens of Salt Lake City, who are already strapped for cash and fighting to make ends meet.
		Below is a list of some of tax increases that affected taxpayers across the state, taxpayers in Salt Lake County, and taxpayers in Salt Lake City in recent years.
		In 2015, a state property tax increase of 3% was passed that was used to equalize the spending of property tax revenue (SB97). Under SB97, every homeowner in the state saw a tax increase, but the \$75 million collected was distributed only to school districts that fell below a set funding threshold.
		Effective January 1, 2016 the state of Utah raised gas taxes by 5 cents with annual increases indexed to the price of gasoline thereafter (HB362).
		In 2017, the state of Utah assessed taxes on all purchases made on Amazon.
		In 2018, the state legislature raised fees and taxes.
		At the Salt Lake County level, we have seen property taxes increase in 2010 by roughly \$100 per homeowner and again in 2013 by approximately \$59 per homeowner.
		And at the city level, we have seen property tax increases in 2013 by approximately \$67 per homeowner, and in 2017 by roughly \$20 per homeowner.
		2017 also saw Salt Lake City pass the first of five sewer rate increases that will ultimately raise rates by 127 percent over the next five years. In 2018 and 2019, this equates to 10 and 15 percent in those years. Moreover the public utilities also increased the cost of water 5 percent this year alone.
		And now in 2018, Salt Lake City wants to increase the sales tax by a half a percent and property taxes yet again.
		Every time a time increase is proposed it is meant to be the panacea to a problem but yet rarely goes away but leads to more and more unfulfilled promises. Living along the Wasatch front is becoming less affordable and increased fees and taxes do little to help struggling families and taxpayers. The question remains when is enough enough? How much money does our government need? All citizens have to live on a budget so why do all levels of government feel they should just increasingly enlarge their scope and place additional burdens on citizens?

As someone who for a long time wasn't able to attend work sessions and didn't understand the straw polling, I was personally dismayed to learn that any comments in a hearing with a vote immediately to follow are essentially too late because you really can't take in new information and substantively change positions on the fly, even if it is legal to do so. That really makes the hearing moot, and you have to sit through it and listen to everyone even though you are ready to vote. I think that the "wait until the next meeting is best practice barring some crucial time crunch. A vote on May 1 should be plenty of time to finalize budget considerations ahead of the new fiscal year. Thank you for your service and your consideration of my comments.

However, it's small in comparison to Liberty Park, which is small in comparison to 'major' city parks like Grant Park in Chicago, Zilcher Park in Austin, Golden Gate Park in San Fran, etc. These parks are sized for the growth the cities have seen. I fear Salt Lake is not prepared for the doubling of population that's expected in the coming decades. The canyons are similarly already full on weekends. Where will these people all recreate? Are our parks appropriately sized?
		Adjacent to Pioneer Park there are several large plots of land that are being offered for development. The larger parcel of ~9 acres is listed at \$22,000,000, while the smaller (3.5 acres) is just over \$9,000,000. There are other smaller parcels in that area that could be purchased to expand the project. If they city were to assemble these properties and extend Pioneer Park (for possibly three full blocks) they could create a legacy that would last for the duration. Development should ignite around these newly formed parks and the city would benefit from the tax increment. Additionally, people entering the city from 600 South (along the proposed Grand Boulevard) would pass by this unique feature.

		We are writing in response to the open public comment period for "Funding our Future SLC" on behalf of Decarcerate Utah, a group of concerned residents of Utah who recognize the deep harm of the criminal justice system, and seek to educate the populace about how we can better allocate resources to create safe, healthy, and thriving communities. We regret not being able to attend any of the public meetings in person, but hope that this written correspondence will be considered when going through the detailed work of presenting a final proposal for the use of funds from an increase in the tax rate.
		We agree with the city that there is a serious need for affordable housing. It is disappointing, however, to see that the proposed budget to supplement more affordable housing options is not even half of the amount of funding proposed to support the hiring of 50 new police officers late last year (a move we also regret was approved). Operation Rio Grande has done more harm than it has helped the homeless population in Salt Lake, and it will take years to undo the damage that was done in a few month's time. We are of the belief that being caught in the web of the criminal justice system sets people back further from stability, or entirely prevents them from having an opportunity to reach such a state of life. Lack of affordable housing is one of the first indicators that a person will turn to illegal or unhealthy behavior in order to make ends meet, or just to make it through another day in life. Providing the support that people need in order to remain housed should be the first priority of any safe community.
		If the funding options are truly limited to the four categories as listed at fundingourfutureslc.com, we would feel much more supported by the city if the budget was dramatically decreased in support of the police officers, and allocate the majority of funds to a logical affordable housing proposal for Salt Lake. After all, when everyone can truly afford a place to live, they are much less likely to be involved in harmful behavior that would put them in contact with an increased police presence in the first place.

4/20/18	FoF Email	I have lived downtown (Marmalade neighborhood) for just over 3 years. I agree with your identification of major issues facing the city. You've done a good job of focusing on what the issues are and what would help fix them. I do have a few concerns with your proposed solution.1. Sales tax creates a disproportionate burden on those with low or no incomes, because they spend a larger portion of their income on goods to sustain life. When their transportation options are limited, they tend to shop at more expensive store (because that's all they can get to), thus paying even more tax for the same goods. 2. Public safety is the #1 responsibility of government; essential infrastructure (especially roads, sanitation & utilities) comes close after. Whatever funds you already have should be directed at these needs FIRST. 3. Housing is a market issue. The best way to help with that is to remove unnecessary barriers to providing truly affordable housing. This includes regulations and zoning. Government has no business directly interfering with the economics - to become a player means you are distorting the market and effectively chooses winners and losers. 4. Transportation is also a market issue. When government gets involved in funding, progress stops. As with Housing, eliminating regulatory barriers is an appropriate way to help, but subsidizing is dangerous. I would suggest reviewing regulations that create "barriers to entry" for people who would LIKE to help others solve their transportation problems (Uber is one current example; bike rentals would be another), and that "play favorites" (favoring one type of service (taxis) over another (ride sharing)). 32
