**I. Convene meeting**

Glen Greener presided over and conducted the meeting, which convened at 5:00 p.m.

Kevin said it seems like there were a lot of accidental discharges this quarter and asked if it was a training issue. Rick said it's unusual but doesn't appear to be a training issue. If this occurs again next quarter, the Board will consider giving training recommendations

to the PD. Brandon found an error on the quarterly report which will be changed prior to posting. Tyson asked how many panel hearings were held this quarter and Rick said there were only 3. Chief Brown said that in part due to a PCRB recommendation, they have instituted a De-escalation Program. Since implementation of this program, at least 37 officers who could have used deadly force, did not. SLCPD will be formally recognizing those officers.

Motion made to approve report by Tyson Carbaugh-Mason, seconded by Brandon Myers. Motion carried; all members present voted aye.
