### I. Convene meeting

Ron Bartee presided over and conducted the meeting, which convened at 5:00 p.m.

## II. Minutes approved

- a) Boyd Ferguson gave a brief Open Meeting Law training session.
- b) Chief Burbank and Sgt. Fred Ross gave a presentation about on body cameras. Sgt. Ross brought some of the cameras to show how small and lightweight they are. Chief Burbank said they are a good record of what is really going on during a stop. The cameras date, timestamp and watermark the video so they cannot be tampered with. He feels they are the wave of the future and the right direction for the State of Utah. He's hoping to have other agencies within the valley who want to purchase these so they can work on getting a group discount. The Chief would like a letter of support from the Civilian Review Board if they agree.

Motion made to write a letter to the SLCPD in support of on body cameras by Anne Albaugh, seconded by Cal Noyce. Motion carried; all members presented voted aye.

**Rick noted**: There were no particular trends this quarter however search and seizure issues were still up. He doesn't believe these are intentional errors and the PD is working on better training their officers. He noted that Salt Lake City's use of force cases were quite low and way below the National Average. He briefly spoke about the NACOLE conference being held in Salt Lake City next year and what the board's participation in that might be. He thanked the board for their time and efforts.
