I. Convene meeting

Claudia O'Grady presided over and conducted the meeting, which convened at 5:04 p.m.

II. Minutes approved

III. New Business

- a) David Everitt from the SLC Mayor's office stopped by to answer any questions and thank the Board on behalf of the Mayor. He also made mention of the delegation coming from Columbia in February to investigate how the PCRB works.

- b) Chief Burbank gave a brief explanation of concealed carry vs. open carry weapons laws and the training his department has received on this issue. He explained some of the different types of grants that his department is receiving and/or have applied for. He said that due to some new technical equipment his office has received they are

able to more actively pursue criminal charges in automobile accidents and as a result the public will notice that occasionally accident locations will be closed a bit longer than in the past.

IV. Review and approve Quarterly Report for October 1 – December 31, 2010.

Motion made to approve report by Cal Noyce, seconded by Nancy Appleby. Motion carried; all members present voted aye.

Rick noted that although the SLCPD Officers have undergone some great training in regards to concealed carry vs. open carry weapons laws he expects to hear more on this subject as new issues arise. As related to previous quarterly trends the SLCPD has heeded the Board's suggestions for further training in specific situations as needed.
