# I. The meeting convened at 5:07 p.m. Claudia O'Grady presided and conducted.

## II. Approve minutes of January 30, 2006 meeting:

Motion: Mr. Kioa moved and Ms. Appleby seconded to approve the minutes for January 30, 2006, which motion carried, all members present voted aye.

#### III. New Business

a. Review and approve quarterly board report for January thru March 2006.

Mr. McCartney said the total rate of sustained cases had gone down due to cases with multiple allegations, which resulted in exonerations. He said there were a total of 10 exonerations.

Ms. O'Grady pointed out that there were a number of cases that the Chief had not made a determination on. Mr. McCartney said those were numerous allegation cases that had been determined but the CRB had not yet received a letter from the Chief.

# b. Update on M files and the Administrator's research on conviction/arrest ratios.

Mr. McCartney said he was working with Information Management Services (IMS) with regard to research on conviction/arrest ratios. He said IMS

was currently working with the Justice Court. He said a tracking system was being set up.

Mr. McCartney said the CRB had asked for M file information in November of 2005. He said he had received an incomplete copy of the information in March of 2006. He said there was a list of 172 cases, some with multiple allegations. He said out of the 172 cases there were approximately 15% to 20% which did not have allegations. He said from the report he had outlined 15 allegations which the CRB would typically be involved in. He said he had asked for more information regarding the 15 allegations and had received the information yesterday.
