Trends/Issues Identified and Relayed to the Police Department

At the very end of the 2nd Quarter, numerous and often daily protests occurred. During these protests several cases were generated and are being investigated. Most, if not all of them, will be reported on in the 3rd Quarter.

A number of case specific recommendations were put forth in those reports and will be included in the 3rd Quarterly Report.

There are four OISs awaiting action by the District Attorney's office, one dating back 2 $\frac{1}{2}$ years. Once they are resolved by the DA's office, CRB will act on those too.

Routine cases have been delayed by the inability to have complainants and witnesses sit for formal interviews due to Covid-19 concerns. Although not optimal, cases are now proceeding with most non-police interviews being done telephonically by Internal Affairs. This too should improve in the not too distant future.
