Trends/Issues Identified and Relayed to the Police Department

The SLCPD continues it string of decreased quarterly complaints overall as well as a decrease in complaints concerning allegations of improper use of force this quarter. This is the second quarter where the number of allegations has decreased from historical numbers and is a very strong indication that the officers of the Department are striving to provide quality service in a highly professional manner.

No "trends" were noted as the allegations that were brought forth were isolated cases that did not show any tendency to indicate systemic unit, or a specific officer, disregard of the policy manual.

The PCRB Chairman wanted to express his concern about the recent task force shooting within Salt Lake City, a shooting that did not include any SLCPD personnel. Based upon facts published in the media, PCRB is concerned about the number of rounds fired, the location of the shooting, the citizens that were exposed to that gunfire and the obvious lack of coordination with SLCPD personnel by task force staff. Media reports indicate that the wanted person was a "fugitive" and PCRB is troubled that a person who was wanted and obviously was located, was not placed under surveillance until such a time that he/she could be safely arrested without exposing the citizenry to such a dangerous situation. PCRB is hopeful that the SLCPD Police Chief and others can take steps to prevent this type of activity occurring within the boundaries of our City.
