Trends/Issues Identified and Relayed to the Police Department

No trends were noted by officer, assignment, or geographical area of assignment.

There are four pending Officer Involved Shootings that remain in the SLCo DA's office:

S18-0003	04/18/18
S18-0009	11/03/18
S18-0011	11/09/18
S19-0003	04/08/19

One of these OISs is very recent and involved officers from three different agencies, has an extensive area of involvement and a great deal of evidence to sort through. One of these OISs, S18-0003 has been in the DA's office for over a year, while the other two have been there for over five months. These three cases greatly exceed the time traditionally associated with review by the DA. CRB, who makes their reports public in such cases, will not proceed until the "criminal review" has been completed in order to protect the rights of all individuals who are involved. (CRB has access to, and uses, "compelled statements" which if released, could unconstitutionally influence the criminal review of the matter.)

CRB has been told that the SLCPD Chief of Police has attempted to get these cases resolved within the DA's office but CRB is requesting that the Chief once again make contact with the DA's office and see if these outstanding matters can be resolved as other OISs, from other agencies, which occurred after these cases, have already been acted upon by the DA. An unnecessary delay results in confusion and anger within the community and results in large numbers of officers being placed on Administrative Leave, causing shortages in shifts and less coverage within the City.
