#### **Trends/Issues Identified and Relayed to the Police Department**

CRB notes that this is the best single quarter in the past 5 years for the low number of serious allegations brought forth by the public. This trend reflects the hard work, dedication, and professionalism of every member of the SLCPD. CRB has looked at every allegation, large and small, and does not find any trends indicating poor performance in any specific area, or by any specific unit of the SLCPD nor of any individual officer. There were no allegations related to "Search and Seizure" law, which is another great result in that in the recent past, "search" issues had repeatedly arisen.

There are a number of continuing investigations that began this quarter that are highly complicated and time consuming but they should be concluded this quarter.
