Trends/Issues Identified and Relayed to the Police Department

In a pending, upcoming case that is currently being examined, the term "Line of Engagement" was heard being used by two SWAT members. A check of the SWAT manual and in discussions with multiple SLCPD officers, the term applies to areas of responsibility during a tactical situation and the related positioning of the officers. It does not apply to the position of the Subject nor is it a shoot/don't shoot line. This term, which is SLCPD SWAT SOP is also known as "Area of Engagement" or even "Area of Responsibility" by other Agencies. All are describing roughly the same issue: which officer is responsible for what and is implemented to ensure all areas are properly covered and to eliminate any crossfire situations. Although the referenced investigation has not found any confusion within the operational Emergency Action Team, all SWAT members, it could be an issue if an EAT is formed that involves non-SWAT members, as occurred during the Trolley Squares incident and likely will again. PCRB is requesting a review/change of this terminology to ensure all officers understand what is being spoken of and to ensure that others, citizens, who may hear it, are aware that the term does not imply an arbitrary line that if crossed, allows for the employment of Deadly Force.
