Trends/Issues Identified and Relayed to the Police Department

PCRB noted a marked decrease in serious allegations this quarter for which the SLCPD deserves recognition. Four cases had allegations of the improper use of force and the panels that heard the three cases that make it to a panel so far all felt the officer's actions were either justified or the allegation, as reported, did not occur at all.

Search issues continue to be a problem as there are two pending search and seizure matters being investigated as this report was compiled but as noted previously, this is not unusual as this is a continuing problem within law enforcement, at all levels and within all jurisdictions. It is recommended that the SLCPD continue to train new officers rigorously while providing continuing in-service training to officers who have been on the job for five years or longer. The amount of time on the job is a good indicator of those officers who are most likely to not be up to date on the changes within the law and/or those who have lost some critical nuances in this area.
