## Trends/Issues Identified and Relayed to the Police Department

PCRB continues to note a significant decrease in the number of complaints, versus historical numbers, and a decrease in significant allegations also. Again, it is recognized that both numbers will most likely creep up towards the more historical number of allegations but it is also likely that they will remain lower than "normal" due to the increased emphasis on eliminating such complaints. An example is the lack of any Search and Seizure related matters again this quarter. Of all the cases reviewed this quarter, no trends as to individual officers or of specific units were noted.

PCRB hosted the yearly NACOLE conference during this quarter and is proud to report that the event was an overwhelming success as measured by the 247 national and international attendees who came for the week long training sessions. Classes offered dealt with trends other oversight agencies are experiencing with heavy emphasis on "best practices" associated with dealing with these issues. Not only were we the host, members of our Board spoke at one class, providing information on how we conduct our duties and the positive effect our actions have for our community. The SLCPD Chief was a keynote speaker at controversial forum while Mayor Becker gave the welcoming remarks to this unexpectedly large gathering. Board members not only attended classes but acted as hosts for the out of town guests who attended. We are happy to report that our model is functioning as well or better than any other city's model and that is due to the quality of citizen volunteer we have hearing the cases that come before us. This conference reinforced the need and benefit of civilian oversight and strengthened our approach to independence with an unbiased deliberative approach.
