Trends/Issues Identified and Relayed to the Police Department

A review of all cases was conducted and no trends were noted as to the entire PD, a specific Command within the PD, a unit of the PD or an individual officer.

It has been some time since CRB has been provided the “Chief’s Letter” on specific cases which prevents the publication of the PD’s findings and associated punishment, if applicable. CRB requests that the SLCPD reinstitute the long standing procedure of sending copies of the final case dissolution letter, also known as the “Chief’s Letter” so that citizens can see the final disposition of matters noted in the CRB Quarterly Report. This action will increase general transparency and had been the standard operating procedure for this past decade.
