No significant trends were noted this quarter. For the year, the SLCPD had two OIS's involving citizens with the last one occurring in February, 2016, meaning that there has not been an OIS in the past 11 months.

The universal use of the Axon Body Cameras by SLCPD officers has truly paid great dividends in that reconstruction of what has transpired in any given event is not only more accurate, arriving at the proper conclusion(s) happens much sooner than before. CRB is extremely pleased that in this past year, there has not been an incident wherein an officer failed to activate their camera in a case wherein a complaint was filed.
