Trends/Issues Identified and Relayed to the Police Department

Overall, no trends were noted in the data. As usual, numerous complaints about rude or inconsiderate contact were made which over the past two years seem to have slightly decreased but are an unfortunate part of policing as most stem from traffic stops. Complaints continue to be lodged over the driving habits/techniques of officers driving marked units although the number of complaints was significantly lower than in the past.

Search related issues continue to be a hot topic with two being reviewed during this quarter: one "Sustained" decision and one "Exonerated" decision being rendered by the respective panels. Officers must continue to be aware of, and sensitive to the changing Search and Seizure laws as they evolve.

As it relates to "force" related complaints, once again there is no trend concerning personnel or specific units having unusual or repetitive complaints filed against them. The complaints filed all seem to be isolated incidents the majority of which stem from a call for service that was leading to an arrest.
