Trends/Issues Identified and Relayed to the Police Department

"Use of force" allegations were significantly lower than in previous quarters during the examined period. This is a great occurrence and is to be commended even if it is simply a statistical anomaly; however it is just as likely a reflection of an increased awareness by officers. Either way, PCRB wants to commend the rank and file, as well as the Police Administration on the success achieved this quarter.

PCRB fully examined two cases this quarter dealing with improper/unauthorized access of restricted or confidential records and the resulting dissemination of that information to individuals not allowed to have that material. PCRB further notes there have been other similar cases that were not adopted for full examination in the recent past and this trend is bothersome. Employees, since improper access was made both by sworn and civilian employees of the Police Department, must remember that accessing "confidential" records is granted on a "need to know" basis and cannot be abused for any reason but especially not for purely personal reasons. It should be noted that in each case examined, even those not adopted for full investigation, PCRB looked to see if the access was in exchange for something of value and that was not discovered in any matter noting the records were generally accessed for purely personal reasons, the most common being for a friend or family member. Employees need to remember that access to such records is restricted for good reason and under no circumstance should they use their position to obtain and disseminate information to some people while restricting access to other people. In the worst case, such transgressions can be used by unscrupulous people to blackmail employees, forcing them via the threat of turning them in, to violate policies and procedures much more significant.

PCRB was requested by the U.S. State Department to provide training to two international delegations who are exploring ways to implement better police institutions along with establishing "Civilian Oversight" agencies. The delegations from Colombia and Albania met with members of this Board, members of the SLCPD and were welcomed by Councilman JT Martin. As civilian oversight of police agencies continues to expand nationally and internationally, it is a great honor that our model and personnel are sought out to provide training to institutions throughout the country and the world.
