District 5 is experiencing a rise in car prowls

SLC Police arrested two people doing car prowls, lots of property recovered from the vehicle

Rise of robberies and burglaries in District 5 and 7

Identified nine more people involved in burglary ring

City crime totals are trending down in every area except for robberies

SLC Police looking for a 6-foot tall white gentleman, wears a mask, pretends he is carrying a weapon

Definition of *Robbery* - threat of violence or physical force;

Definition of *Burglary* - no threat of violence or physical force

Safe Cam - SLC Police administers a network of privately-owned cameras on private property that the city can reference in case of an incidence

SLC Police can assist residents in placing outside-the-home security cameras; call them to ask for help

SLCO Lead Safe Housing Program ([link](#))

The county's Lead Safe Housing Program focuses on lead abatement in homes built before 1978

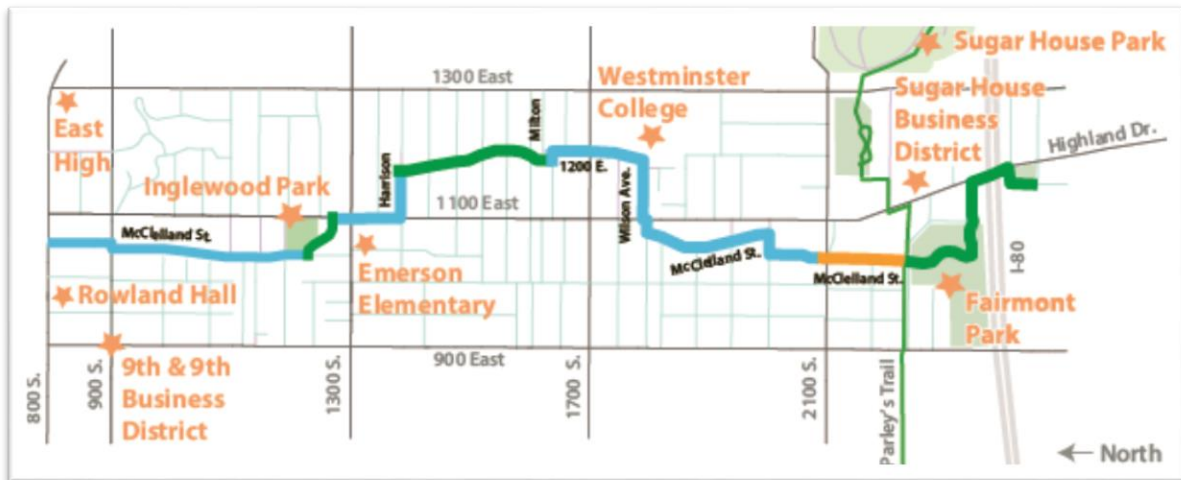
There are several criteria for a home to inspected for lead contamination:

- Home built before 1978 (for homeowners and renters, but landlord permission needed for renters)
- Homes with children under age 6, or pregnant women
- Also grandparents with kids who visit at least 6-hours a week or 60-hours a year
- Income requirement: At or below 80% of the area median household income (confirmation requires two months of pay stubs)
- Program available only for Salt Lake County residents

Lead Safe Housing Program will conduct a risk assessment of the home, with sophisticated equipment

Dust sample analysis, \$500 test, interior and exterior
 Program can replace older wooden windows—a savings of thousands of dollars to home-owners
 Program looking for 40-50 more homes to test in Salt Lake County
 Takes 60-90 days from start to completion of evaluation project
 Online application available at Lead Safe Homes website ([link](#))
 Average \$4000-\$5000 in repairs with certified lead specialists
 Program can also test for Radon, and can assist with radon mitigation if lead problem is also discovered, which is \$1000 average
 Residents can test their homes themselves for radon for \$8; home tests available at most hardware and home improvement stores

Update on the McClelland Trail ([link](#))

Construction on the McClelland Trail scheduled to begin this summer on a new walking and bicycling route in the heart of ELPCO. The trail stretches from 800 South to Highland Drive south of I-80.
 The McClelland Trail follows the route of an open canal that flowed from the headwaters of the Jordan River to the Great Salt Lake
 In the 1910s the canal was covered over and diverted to a culvert
 City retained the right-of-way with the canal underneath it. The canal still flows underneath the streets and alleys.
 Fast-forward to 1980s, ELPCO originated the idea of a neighborhood corridor for walking/biking
 McClelland Trail concept started making its way into SLC Master Plans
 In the early 2000's ELPCO put together a CIP request along with the Sugarhouse Community Council to give the SLC Transportation Division funds to build trail
 In 2010-11 funds were allocated to SLC Transportation to develop an implementation plan
 McClelland Trail implementation plan was adopted by City Council in 2013
 SLC Transportation currently has funds to build trail from 800 S to 2100 S; ELPCO appreciates the work of Council member Erin Mendenhall for supporting the funding for the McClelland Trail project
 Second phase of trail construction will continue the trail from Sugarmont Plaza to The Brickyard
 Some of the trail runs along streets like 1100 E and McClelland Street. Trail construction will improve street access by making better bike lanes along 1100 E between 1300 S and Roosevelt; additional stripping instead of a larger bike lane
 Maintenance for the trail will include trash pick-up, dog waste stations, and winter-time plowing
 Adding lighting to the trail would take up entire budget; but it could be done in the future

Previous McClelland Trail workshops held on October 7, 2015

Attended by 40-50 people who prioritized aspects of the trail

Residents wanted high visibility crosswalks, a clean alleyway, and they didn't want fast cyclists zooming by them at top speed

Construction will be finished in fall 2016

SLC Transportation negotiated access agreements with property owners who have encroached on the 66-foot wide right-of-way in the alley sections of the trail.

SLC Transportation staffers went door-to-door along the corridor to work with each property owner

When Engineering Division is going to be doing work along the trail there will be a lot of public notice

Meeting adjourned at 8:10pm

WHY IS LEAD HARMFUL?

- Lead causes health, behavior, and learning problems especially for children under 6 years of age
- Continued exposure can result in permanent injury
- Lead harms unborn babies and pregnant mothers

WHERE ARE LEAD HAZARDS FOUND?

- Interior or exterior painted surfaces that are chipping, or peeling, and friction surfaces like windows and doors
- Dust, bare soil, varnish, water, and plastic mini-blinds
- Homes built before 1978 may contain lead based paint; homes built before 1950 are at higher risk

PROTECT YOUR FAMILY!

- Apply for the Lead Safe Housing Program's free services
- Get your child tested for lead poisoning (testing done by finger prick)
- Have your home tested for lead or ask your landlord about lead in your home (if built prior to 1978)
- Have your child wash their hands often
- Keep areas where children play dust-free and clean
- Mop floor, wipe window ledges and chewable surfaces with all purpose cleaner and warm water
- Encourage children to play in grassy areas instead of in the dirt which could contain lead

¿POR QUE ES EL PLOMO PELIGROSO?

- El Plomo causa problemas de salud, comportamiento y aprendizaje especialmente a los niños menores de 6 años de edad
- El continuo contacto con plomo puede resultar en daños permanentes
- El Plomo afecta a los bebés por nacer y a las mujeres embarazadas

¿DONDE SE ENCUENTRAN LOS PELIGROS DEL PLOMO?

- Sobre el interior y exterior de las ventanas y puertas que muestran pintura deteriorada
- En el polvo, tierra, barniz, agua, y persianas de plástico
- Viviendas construidas antes de 1978 pueden tener pintura a base de plomo. Casas construidas antes de 1950 están en alto riesgo

PROTEJA a SU FAMILIA!

- Solicite para servicios gratuitos Libre de Plomo en Salt Lake
- Lleve a su niño/a que se le haga la prueba de Plomo (el análisis de sangre es solo un picazón del dedo índice)
- Han hecho la prueba de plomo en su casa o ha preguntado al dueño acerca del plomo en su casa (construida antes de 1978)
- El niño/a debe lavarse las manos con frecuencia
- Mantenga las áreas donde los niños juegan libre de polvo y limpio
- Mantenga los pisos, las repisas de las ventanas, y objetos masticables limpios, labelos con limpiador de uso múltiple y agua tibia
- Insista que los niños jueguen en lugares sin tierra o polvo. La tierra puede tener plomo
