MILLCREEK, UTAH RESOLUTION NO. 18-23

A RESOLUTION OF THE MILLCREEK COUNCIL REQUESTING SOME BOUNDARY ADJUSTMENTS WITH SALT LAKE CITY

WHEREAS, the Millcreek Council ("Council") met in regular session on May 14, 2018, to consider, among other things, a request for some boundary adjustments with Salt Lake City; and

WHEREAS, Utah State Law (Utah Code Ann. § 10-2-419, et seq.) provides that adjacent municipalities may adjust their boundaries based on mutual agreement; and

WHEREAS, Millcreek has recently incorporated as a city and there is a fresh opportunity to look at boundaries with neighboring municipalities; and

WHEREAS, public safety response times, accessibility, and reduced jurisdictional confusion should be a critical consideration of municipal boundaries; and

WHEREAS, some property owners have approached Millcreek with desires to deannex from Salt Lake City and annex into Millcreek; and

WHEREAS, some properties currently within Salt Lake City boundaries are critical to Millcreek's planning of a City Center, community gateways, or other civically significant activities.

NOW, THEREFORE, BE IT RESOLVED by the Council that the formal request is made to Salt Lake City as follows:

SECTION 1. Brickyard Area. The Council requests that the boundary with respect to the peninsula of Salt Lake City jutting south at approximately 1100 East and 3000 South into Millcreek, commonly known as Brickyard Plaza, be changed so that this peninsula is included in Millcreek. Since there is tax generated in this area, it is proposed that Millcreek take the 2017 amount of taxes that Salt Lake City had collected and place the equivalent dollar amount, minus an allocation for public safety, into a fund to help finance a southward extension of the S-Line Streetcar each year for ten years.

SECTION 2. Tanner Park and Parley's Historic Nature Park Area. The Council requests that the boundary with respect to the areas of Salt Lake City south of I-80 and east of 2300 East, including the roundabout belonging to the Utah Department of Transportation, Congregation Kol Ami Synagogue, Tanner Park, and Parley's Historic Nature Park, be changed so that this area be included in Millcreek. If the boundary is adjusted, Millcreek would assume the cost of providing public safety to this area.

SECTION 3. Millcreek North. The Council requests that the boundary known as the northern boundary of Millcreek and southern boundary of Salt Lake City between 2300 East and 700 East be examined. While the Council does not have any specific proposals for boundary adjustments in this residential area, they invite Salt Lake City to send

representatives to meet with counterparts from Millcreek to construct a proposal for a more logical and mutually beneficial line here.

<u>SECCTION 4.</u> Request Submitted to Salt Lake City Mayor and Salt Lake City Council. The Mayor is directed to submit this request to the Salt Lake City Mayor and Salt Lake City Council and the Mayor be authorized to initiate negotiation with Salt Lake City as contemplated herein. This Resolution, assigned No. 18-23, shall take effect immediately on passage.
