Several of these spaces are already frequently used by current residents. Emergency vehicles may be hindered! There will not be anywhere for visitors to park, and it will much more difficult for all traffic to navigate a street that can already be tough at times. There are also potential problems when it comes to snow removal. It will be difficult with all the parked cars, narrow set backs, lack of parking strips, driveways and sidewalks, there is very little space to pile snow. With the proposed set backs the buildings will only be about 5' from the sidewalk and about 9' from the street, there is no parking strip on either side and the homes on the south side of Cleveland are close to the street as well. There are several other concerns with the narrow set backs and on street parking. For the existing residents that have garages on the alley access in and out will be hindered, entering and exiting the alley will be difficult. I already have to jockey my way in at times because of parked cars when I am in my work truck, this will likely be a daily occurrence when this development is completed, regardless of the number of units. When exiting it will be difficult for us to see cross traffic from the east as the building will block the view and the view to the west is already almost completely blocked by a fence, a result of poor zoning regulations. It is inconvenient at least and potentially dangerous for those of us that use the alley. The residents on the west side of the development will likely find it difficult to access their garages because of the set backs. One of them is about 16' from the edge of the alley, mine is over 22' and I can just barely make it in and out without jockeying around, and I have a tight turning radius. Instead they will be enjoying the growl of 7 AC compressors day and night all summer long, and a blank slab of wall 30' tall instead of a view of the mountains. Several of the neighbors to the west are also concerned about their blocked view. In addition these tall walls on all 4 sides are mostly slabs with garage doors and few windows, it would be more appropriate in an industrial complex than in a neighborhood with about 95% single family homes that are more traditional architecturally. The City has failed miserably to provide incentives for the redevelopment of nonconforming uses, surface parking lots, and single story commercial buildings. 3 The FBUN-1 and -2 were developed at the request of the RDA specifically for the West Gateway and were applied in a comprehensive rezoning there. The zones were adopted City-wide unfortunately and have been applied piecemeal elsewhere. Some of you will recall that you had to fix the FBUN-2 because there were no setbacks unless the abutting zone was FBUN-1. In other words, these zones as developed were intended to be used as part of a comprehensive rezoning. 4 As someone who has lived in the Bryant neighborhood for 45 years, I will tell you that you do a profound disservice to a neighborhood when you give a property owner development rights which the abutting property owners do not have. However, as an at-risk person myself, I feel it is largely up to me to not go into crowded places or participate in large gatherings, practice proper hygiene, stay away from people with exhibiting symptoms, etc. It is not sustainable for an entire locality, let alone state or nation, to shut everything down due to an illness that is fairly mild for 80% of the population. People are ultimately responsible for themselves. Going along with this, the people of Salt Lake have done a great job so far following CDC and local health guidelines. The notable exception was the large gathering at the Salt Lake International Airport earlier this week where hundreds of friends and family members greeted returning LDS missionaries from over-seas. However, the community's and LDS church's reactions to that gathering indicate that most people take COVID-19 and the current measures for mitigating it seriously. If most people are monitoring themselves, then I see no need for the government to further restrict their movements. Salt Lake has the opportunity to provide an example to the state and country in this respect. Second, Salt Lake City is unique for its vibrant local business community. The local economy is already under significant strain due to COVID-19 and businesses are working

Again, Salt Lake can lead by example by keeping the local economy as strong as possible during this time. Finally, a shelter-in-place order or lockdown is impossible to enforce without imposing martial law. This would divert our police force from more pressing issues, such as the increase in domestic violence calls departments have recently received that are due, at least in part, to more people sharing close quarters in a stressful situation. Even if police were solely charged with keeping people in their homes, it would still be an impossible task. They cannot be everywhere at once, and it would require people to tell on their neighbors, which many wouldn't do. Most important, enforcing a shelter-in-place or lockdown is unconstitutional. Desperate times call for desperate measures, as the saying goes, but our current times are no more desperate than previous eras and we do still live in the United States after all. I want to close by emphasizing that I understand the complexity of this situation. Coronavirus poses many unknowns and I think everyone wants to help the most vulnerable members of our community. However, it is crucial we do not act out of fear and remain as rational as possible. For example, instead of bailing businesses out, can the state or county provide incentives to businesses to provide goods or services for combating the virus in some way? Such a measure would keep more people employed, give local businesses a boost, keep money flowing in our economy, and help mitigate coronavirus. Involving more people would also better educate the public, and get more individuals on board with	e

City HOPWA (Housing Opportunities for People with Aids)

Program Description: The Housing Authority of the County of Salt Lake (HACSL)'s HOPWA program provides permanent housing opportunities through rental assistance for persons living with HIV/AIDS in Salt Lake County. To ensure that those most in need in the community are served, HACSL accepts referrals for program openings from the prioritized wait list managed by Utah Aids Foundation (UAF). UAF compiles the list from the two HIV/AIDS service providers in Salt Lake County, UAF and Clinic 1A. Those assisted with the HOPWA program pay 30% of their monthly- adjusted income towards rent.

Demographics:

- 52 Households currently on the program (10 elderly, 15 families, 37 single individuals)
- 84% of households served are extremely low income (30% of Area Median Income or below) with the remaining households falling under very low-income
- 12 households are employed, 21 receive social security payments, and 23 are receiving state assistance of some kind
- The average annual income is \$9,286.00
- Per Utah Aids Foundation medical expenses can vary but average around \$2,200 per year for insurance premiums

Program Need:

- Utah Aids Foundation currently has 65 households in need of housing assistance on the HOPWA prioritization list.
- The HOPWA program is the currently the only programming/funding providing housing specifically for this population in the state of Utah. In Utah HIV/AIDS has infected over 3,000 people.
- People with AIDS are at a higher risk for homelessness. The high cost of medical treatment may make it more difficult to maintain stable housing. The National Alliance to End Homelessness states "Due to factors such as poor hygiene, malnutrition, and exposure to cold and rainy weather, homeless people are already three to six times more likely than housed people to become ill."

Outcomes: As reported in our June 2019 CAPER

- 100% (58 out of 58) households maintained housing stability (55 remained on the program, 1 moved to permanent housing and 2 transferred to other subsidy assistance)
- 1 household obtained employment

Thank you for your time and thoughtful consideration of the many worthy programs that serve the needs of Salt Lake City residents, along with limited available resources. Additionally, I am personally thankful for the committed support The Road Home has received from Salt Lake City for so many years partnering to serve people in dire circumstances and for the current close collaboration with the City Council and Mayor's Office to prevent the spread of COVID-19 among people experiencing homelessness.

We are incredibly grateful for the recommendations of both the Mayor and Advisory Board to fully fund our HOME Tenant Based Rental Assistance request. We have an Emergency Shelter request before you that would enable The Road Home to provide for a person's basic needs when they become homeless during cold weather through services provided at St. Vincent DePaul. In the last few years the City has provided funding through other sources and we hope that support will continue.

We also have a request before you asking \$150,000 for our Rapid Re-housing Program and \$97,200 for Housing Navigation Services to enable people to find housing. Both programs align with the Federal, State, and Salt Lake City's plan strategies to assist people experiencing homelessness to move swiftly into permanent housing with appropriate person-centered services. Case management and housing location supports are important keys to helping our community ensure the capacity and success of the new shelter resource center model. The need to help people move quickly into housing is even more critical during this COVID-19 outbreak, where shelter represents dense-living in a congregate setting.

Housing Navigation Services accelerates moves by helping people create housing plans, identify housing opportunities, and navigate the process from start to move-in. Case management remains an underfunded but essential component that helps unlock the longer-term success of housing stability to prevent a household's return to homelessness. Case management, in tandem with rental support, is the boost nee'ded to lift people back into our community.
