I've been out on short term disability due to a surgery on my left shoulder and watched my coworkers and team mates on the Public Order Unit which I'm also a volunteer member. I'm proud of the job they did in stopping the violence and unrest in the streets of Salt Lake City. We?ve been trained to a standard that Metropolitan Police in the United Kingdom and other countries around the world use to safely disperse large unruly or violent crowds. I'm proud of the training we?ve received and equI'ment, but more should have been provided long ago when we first started in April 2015, let me give you an example. While then candidate Donald Trump was running for office and visited the State of Utah on March 18, 2016, I was one of the officers stuck between two opposing crowds trying to keep them separate. We were finally able to gain a line of officers to protect the building, which was being used against a large crowd that wasn?t happy he was in the State. During a after action de-briefing Chief Brown asked what we may need in equI'ment and training to better prepare. I suggested we needed some form of better communication since I could barely hear through my radio ear piece any commands or communications coming through and over my radio. The department has provide some of the protective equI'ment need, but only after we?ve had additional protests that could have turned violent. I have equI'ment to protect my body, but have not been issued the appropriate helmet again because of funding
		in purchasing enough. I do have a ballistic helmet which is not designed for these type of deployments. The appropriate helmet used by the public order unit were distinct in color (Blue, White, & Yellow) which are designed to protect from injuries to the head, but also have our individual badge numbers attached to
		them. These helmets can be outfitted with radio headsets to help in the communication aspect to safely execute a plan quickly and safely. If anyone has these headsets installed in their helmets it's only a few, and it poses hazards to the remaining officer and public by not having the clear communication need in

I highly support moving programs like park rangers and social workers outside of the police department. This action makes these programs safer and more accessible to Black people, non-Black POC, and people experiencing crisis. While this step is in the right direction, police departments in the US are inherently racist, so I hope that the council and council staff continue to consider additional programs that can be separated from the police budget. I think this is especially pertinent to services for constituents experiencing homelessness. While I understand this may feel like "rel'venting the wheel," what is being demanded is that the council begin dl'mantling oppressive systems in our city. As long as ANY public services (especially services designed for people in crisis) are under the umbrella of the police department, they are not equitable. Perhaps this has been lost in translation in the requests for polic funds for the purchase of militant equi'ment. However, you and councilperson Johnson mentioned that while the implementation of "military-grade" tactics and weaponry is against your values, that training exercise needing munitions is somehow less violent to the citizens of SLC. I would highly encourage the council to move a significant portion of the proposed \$84 million police budget into social services, homeless services, services that assist racial justice causes and support marginalized communities, etc (I recognize some discussions are being held about such potential diversions, though I am not yet familiar to what degree). It is cheaper and far more productive to put money directly into homeless. Housing first, not policing first. I do not bell've police should be asked or assigned to be overseers of social problems such as homelessnes, addiction, poverty, etc. in our city. They do not have the education, training, or resources to do so. The city needs more social workers, nurses, doctors, therapists, treatment beds, shelter beds, housing vouchers, etc. Every time the police park a patrol car for the day at Library Square, Washington Square, Taufer Park, etc., just to make sure individuals don't spend too much time there or sleep there, it costs the city hundreds of dollars and diverts potential funding away from the individuals they are monitoring.
