One of the major problems, is that even if those committing the crimes are caught, they are just about immediately let loose to continue their ways the next day! In my opinion, this problem was one of the major factors which resulted in your election. We hope that you will be able to address this problem and would be more than willing to visit with you about the history of what has occurred and not occurred, and how we can assist you in achieving our objective. I'm vice chair of the EBCC and I am very concerned to have our police department's budget cut by 5 million plus dollars to reallocate some 2.5 million to social work and another 2.5 million to be held in reserve for other options. Our area has been short of basic police coverage for years and efforts by the City Counsel last year were made to hire additional police officers to meet the needs city wide including our area. Last year we were told that the Police Department was trying to hire 50 additional officers but applicants were not as forthcoming as hoped and careful training of new police officers takes up to a year. Now the Council has put a hiring freeze on the police department. How does this action solve the existing shortage of officers? How will social workers fill the gap for needed enforcement and coverage? I would hope to see the 5 million dollars originally budgeted for the Police Department spent to upgrade our police force. More competitive salaries and education requirements for them would go a long way to solve the problems of enforcement. I am reaching out to you to demand that you do more for Bernardo Palacios and the people of Salt Lake City. We want the release of all 5 body cams of the officers unedited and complete. We need these officers to be fired and charged for murder. We also need the civilian review board to be properly equipped to provide oversight, which includes the ability to hold these officers accountable. Those on the civilian review board should also be impartial. I have been a victim of police brutality in Salt Lake City when an officer ordered my partner a ~100lb Latina to sit and after complying with the order he picked her up and threw her into the street. I jumped from my sitting position in shock, where I was met with mace and a beating. These officers then charged me with disorderly conduct and resisting arrest. Luckily, I struck a deal with the judge to do a plea in obeyance so those charges were later removed, but I am one of the lucky ones.
