I support redirecting funding for the police department to social services, and I think the actions the council took last month are a step in the right direction. I heard a segment on NPR that talked about a program called CAHOOTS in Oregon where social workers and medics respond to 911 calls or non emergency calls that involve mental health issues. CAHOOTS handles about 20% of the 911 calls, and estimate they save about 15 million dollars per year in costs (ER room visits, EMS, and police response). The CAHOOTS program costs only 2.1 million per year. To put that in perspective, the police budget in the two cities CAHOOTS works with is 90 million dollars a year.
