Two Saturdays ago, November 21, 2020, my friend and I took a walk in Sugarhouse Park to enjoy the afternoon sunshine. I had my 9 month old baby and dog, and she had her dog as well. As we walked the popular circle with many other Salt Lake folk that day, we were accosted by a long chain of vehicles carrying signs and flags in support of Q and Donald Trump. My friend and I were wearing masks and many people in that group shouted at us to take off our masks. This was only slightly alarming compared to what we came across next. Shortly after rounding the last turn, we saw that most of the vehicles had pulled over. Among those exiting those vehicles were several men carrying what appeared to be high caliber assault rifles. They stood by, along the side of the road, in a threatening manner. One boy, who appeared to be underage, followed us as we walked, after I told him several times to back away and stop following us. As we had to drive back through this rally to exit the park, the friend who I was with, who is Black, was verbally accosted by another armed man who said to her, "we are going to kill Black people." He also used vulgar language. There are so many layers to this event that are troubling, it would take some time to break them all down. The most notable, in
		addition to the racially charged threats, is that my friend and I, two women and a baby, were unable to go safely on a walk in our own public neighborhood park. For this reason I am appealing to you today, as
		our city council, to encourage those in a position to do so, to put in place an ordinance or a law that prohibits the use of the open carry of weapons in public parks. I strongly bell've that we can all agree,
		regardless of political view or party, race or gender, that we should all feel safe enough in our neighborhoods and public spaces to take a sunny Saturday afternoon walk in the park. In support of this
		measure, I have created a petition and am currently collecting signatures from concerned community
		members. I am happy to share these with you once collected. Thank you so much for your time and

I have two issues I could use your help with. First, the scene of the truck accident on 2100 S 2300 E where the statue of Parley Pratt was is an absolute mess. Even weeks after the crash there is a significant amount of debris and more concerning diesel fuel remaining. I'm not really concerned with what will happen with the statue. My concern is when will that area get cleaned up. It can't be good for our environment to have all the diesel fuel residue and oil sitting there. Secondly, there is an increased homeless encampment presence by the mouth of Parleys Canyon. There is someone living under the Foothill Overpass on the Parleys way exit. There is a lot of garbage and human waste accumulating there. Last week at night, I was taking that exit and an individual with a bike was crossing there on his way to camp. I nearly hit him. It is unsanitary and unsafe. There are also more camps just east of where the Shoreline Trail crosses I-80. Those camps are about a mile east of the bridge. An ill-conceived effort was made by the administration to augment patrol numbers by pull detectives from their positions and placing them in patrol. The immediate and obvious result of this lack of staffing is officers are unable to respond in a timely manner due to the sheer volume of calls. I recently had an encounter with a man who was a victim of theft and was so angry he would not even meet with the police who responded to the call (20-220080) due to the time it took officers to respond. Most people are more understanding, but that empathy is waning. Another consequence of this lack of staffing is patrol officers are daily forced to make a choice between the quality of service provided on each call verses the quantity of calls responded to. More and more providing citizens with a service that they appreciate is sacrificed for the sake of trying to cut down the number of calls holding. The this dilemma persists the more a culture of poor service will become the standard. With a greater back log officers are forced to deal with fewer lower priority calls which are held in reserve until the slower time of day when citizens either give up or are forced to deal with an issue telephonically because the time for action has passed. During the busiest time of day officers deal with more frequent and higher priority calls. Officer not only endure greater stress, but are being placed at greater risk regularly. Officers frequently have to stage nearby on high priority calls waiting for a backing officer who may be minutes or approaching hours away. As these officers face greater danger,
		greater stress with fewer resources they can take comfort in the calming words of the mayor that they are welcome to work someplace else. At what point is the mayor and city council held accountable for their actions? The response to the rise in calls is that many well-intentioned sergeants actively review
