I'm writing to let you know I support the current efforts to build more trails in the Foothills — and I do NOT want to see those efforts curtailed or suspended in any way. Here's the number one reason why. As Utah becomes more and more and more urbanized, which is inevitable and accelerating, the best outdoor recreation is concentrated as close to our cities as possible. We are not going to stem the flood of people who want to move here in order to hike and ride bikes. So, in order to keep that from being destructive to locations that remain relatively pristine, we must funnel as many people as possible to urban wilderness interfaces. Those areas already have tons of human traffic and human effects and have for decades. There's also the part where people make less carbon when they visit places closer to home. I'd much rather see thousands of people hiking and biking in the foothills than I would see that same number driving an hour to areas that remain something approximating real wilderness. The climate crisis is real and getting worse: Dense cities are the greenest places on Earth. We need, as much as possible, to keep people living, working, and recreating in dense urban environments. I'm sure these trails are not perfect. Everything is a work in progress and can be improved. As you move into Phase 2 and beyond, it would be awesome to improve that work to make it as environmentally benign as possible. But, suspending work feels to me like exactly the wrong thing to do. We lose momentum, perhaps we lose funding, and we end up with fewer trails — in the exact places we need more of it. The Phase 1 plan has demonstrated countless instances of poor trail design and construction. Citizens have reached out to the City, PNUT board, and Parks Department with concerns throughout the entire process. As a civil engineer that studies rock and soil failure, I see numerous poor practices, especially in lower City Creek, that will continue to experience soil instability issues for years to come. The Morris Meadow ridgeline is a prime example. The Parks Department had the legacy ridgeline trail closed under false pretense so they could construct two unnecessary parallel trails to the ridge along the hillside, both through pristine meadows. To discourage users from using the stable ridge three 40' long tranches and barriers were constructed. Each of these has failed to discourage users as the ridgeline trail makes the most sense for natural travel. As observed in the image below, these barriers have been poorly constructed and now one of them has fallen down. I am asking the city to either repair the ridgeline trail to its former state or in the meantime fix the barrier. Additionally, I beg you to not move forward with the presented Phase 2 and Phase 3 plans before more damage like that observed in Phase 1 occurs. Last year, we were in a very different situation to this year. At that time, many argued that, although kids have a statistically almost 0 percent chance of dying from Covid (and, in Utah, the numbers are even better considering we've had 2 pediatric deaths TOTAL since the start of Covid), they could potentially bring home the virus to those in their family who are immunocompromised or otherwise at risk for developing serious Covid complications or death. Or, the argument was that teachers and other school personnel were also not protected and that children could transmit the virus to them, thereby potentially harming or killing this group of people. Now, ALL of those that are in these categories have the chance to be protected through vaccination. So, why are we still proposing requiring children to bear this burden of "protecting" other groups of people when they themselves have such a miniscule risk of dying or developing serious complications? Is it right to ask children to bear this burden for others? Another argument that is being circulated is that not ALL children will survive Covid or survive Covid without possible long-term issues. This is true, but again, look at statistics. This group is in the severe minority and we don't base public policy on the severe minority of people, but on the majority.
