SALT LAKE CITY'S REDEVELOPMENT AGENCY CONTINUES TO PAY ITS MAINTENANCE WORKERS TO SUPPRESS INFORMATION, HIDE THE TRUTH, & HIDE THE HISTORY OF THE PUBLICLY OWNED UTAH PANTAGES THEATER AS POSTERS EXPOSING THE RDA'S OWN CORRUPTION ARE TAKEN DOWN OVER THIRTY TIMES

SALT LAKE CITY, Utah – September 3, 2021 – Shouldn't city workers, whose salaries are paid for with tax dollars, only be engaged in work that betters the community and people they work for? Is it really the best use of resources, money, and time for city workers to be hiding and suppressing information from the public? Those are some of the questions many members, followers, and supporters of "Save the Utah Pantages" continue to ask themselves as they remain embroiled in a battle over posters with Salt Lake City's Redevelopment Agency and their building maintenance workers. Earlier this May, widespread fraud, corruption, and lies were revealed in the city's RDA, a powerful city agency that manages dozens and dozens of acres and tens of millions of dollars of publicly owned property all across the city, including the Historic Utah Pantages Theater. All of this property was purchased with tax dollars and is therefore owned by the people of Salt Lake City.

As soon as news of this corruption broke to the public, corruption that involves RDA Director Danny Walz and Deputy Director Tammy Hunsaker, posters begin to go up on the walls of the theater on Main Street. Information on these posters includes tangible and objective proof of these allegations of corruption, details from meetings and RDA memos attempting to cover up that truth, links to websites, google drive folders with hundreds of collaborative documents, access to the full investigation, and ways to support the reopening and protection of the publicly owned grand movie palace. These posters have been expanded to now include history, photos of the interior of the theater both historic and current, and future plans for what a historic theater district in a fully restored century-old theater could be.

But as soon as these posters went up, they begin to come down by orders of the very person these allegations indict: RDA Director Danny Walz. Danny has spent the entire summer and an ever-growing portion of city labor funds to keep these posters and this information from the eyes of the public and very serious questions of his misconduct hidden. These are posters that expose corruption, educate citizens about the historic

property they own and highlight the truth that is backed by national historic theater restoration experts. These posters are read dozens of times every hour, with the vast majority of people having no idea what really stays purposely buried behind the unflattering facade they walk by and see, that is until these posters educate them of reality. The RDA's actions beg the question if this city agency really has nothing to hide, if these allegations are in fact untrue, why are they so quick to suppress information from the community they work for? Why has no third-party investigation been completed even after being called for by large portions of the community? Why waste tax dollars paying workers now over thirty times to remove public information from a public building? Why stifle dialogue and conversation, continue to discredit national historic experts, and keep a publicly owned theater hidden from the people who actually own it, who deserve the facts and real answers?

Why is a public, unelected city agency working so hard against the very people of the city and people they are there to serve in the first place?
