Dear Mayor Mendenhall, City Council Members, and members of the CIP Review Board,

The Bicycle Advisory Committee (BAC) has reviewed the proposed list of the Transportation Division and Constituent CIP projects as presented to the committee. Keeping in mind the importance of providing safe spaces for all users of the Salt Lake City transportation network, we support the funding of projects listed under CIP for Fiscal Year 2025.

The CIP project list was reviewed by the BAC and the Transportation Advisory Board (TAB). Both groups were able to provide a project priority ranking, which was then compiled into an overall priority score. Attached is the ranking of a combined list of both Transportation Division and Constituent CIP projects. The list is ordered by score, where the higher the score, more priority was given. Of the 12 members of the TAB and 7 members of the BAC who voted, there is high priority given for funding the existing programs which the Transportation Division is overseeing. Using the scoring column as a metric, the top ten projects ranked similarly with a range from 202-279, showing general preference for these programs, but no clear indication of a preference of one program over another. These programs include the Livable Streets Program, Safer Crossings Citywide, the Neighborhood Byways Program, and the Urban Trails Program, among others.

While many constituent location-specific projects did not rank as a high priority in this list, the BAC would like to express that there is support for funding some of these projects, especially those with lower costs like the 500 E raised crosswalk. We understand the unique needs for improvements throughout the city, specifically at these locations mentioned in the project list, but also recognize that the programs implemented require funding to accomplish those same goals in many places throughout our city. In addition, many of these programs will also improve the safety of children as they find safe routes to school. The TAB encourages the Mayor's Office, City Council, and the CIP Review Board to approve funding for the projects listed in the CIP, with an emphasis on the existing programs, so that Salt Lakers can continue to move safely and comfortably throughout our city.

			experience several unstable LDS Hospital patients make their way to this bus stop location, in the past several
			weeks. The following is what has been reported to me, including what I have personally experienced (we have
			pictures and video of these incidents): On January 16th, a patient left LDS Hospital ED in a wheelchair and was
			followed by several security guards and hospital employees, as he eventually made his way into the middle of the
			road, on 7th Ave and C Street. The SLCPD were called and an ambulance responded. This patient was obviously
			impaired and disoriented and hospital employees did nothing to assist him, but waited for paramedics to arrive.
			It was unclear if this patient was attempting to access the bus, but had no other means of transportation.
			Neighbors who witnessed this event were saddened and concerned that these types of occurrences continue to
			happen. On January 17th, two biohazard bags were left on sidewalk at the bus stop location by a patient, who left
			LDS Hospital ED late at night. These bags were never picked up by UTA or LDS Hospital and continued to litter our
			neighborhood for several weeks, as nobody wanted to touch them, due to fear of contamination of infectious
			disease. On January 22nd, an individual (not a confirmed hospital patient) entered my backyard property and two
			of my neighbor's properties. When confronted, he reported he was waiting for the UTA bus. He was asked to
			leave several times, but continued to loiter on my property and my neighbor's property instead of waiting at the
			bus stop. On January 31st, a LDS Hospital ED patient camped out overnight at the bus stop located at the
			hospital, on 7th Avenue. They wandered around the neighborhood, knocking on doors, and asked neighbors for
			food and clothing. He left a sleeping bag, food, and several personal items, including medical waste at the bus
			stop and on the sidewalk. His waste wasn't cleaned up for several hours after neighbors reported the issue.
			Again, having a bus stop, that primarily serves LDS Hospital ED patients, located at a residential home with small
			children, in a neighborhood with small children, is not a safe or responsible decision. As UTA change day
			approaches, we are asking that this stop be removed or moved to hospital property, to better accommodate the
			people who are using it and to reduce the negative impact it is having in our neighborhood. We are proposing that

Utah Glass Bottle Redemption Program (UGRP)

Seung Joon Lee

I. BACKGROUND

The accumulation of 87,908 cubic meters of empty glass bottles annually, akin to erecting a four-story structure on a football field-sized base, signifies a pressing environmental challenge. Despite Utah's vast expanses of unused land, this reality persists, compounded by the adverse effects of landfill emissions—chiefly methane gas and groundwater contamination. While the recyclability of glass offers a sustainable solution, the inadequacy of existing recycling programs leads to the majority of glass bottles ending up in landfills. This plan is written to confront this issue in Utah.

Although my county hosts a public recycling program, it does not currently support glass bottle recycling, leaving it to individual citizens' discretion. To advocate for expanding recycling services, my high school club members and I collected glass bottles weekly from five bins that I installed near my home. I personally transported 1,880 pounds of glass to the Utah State University recycling center for about nine months in 2019. Drawing upon insights from industry experts like Pierre-André Mongeon of Machinex, I am introducing policy recommendations tailored to address the unique challenges associated with glass recycling. This may include investing in advanced sorting technologies, expanding curbside collection programs, and incentivizing businesses to adopt sustainable packaging practices (Recycling Product News). Additionally, the proposal will advocate for legislative reforms to establish minimum recycling

standards² and promote producer responsibility initiatives, encouraging manufacturers to prioritize eco-friendly packaging solutions.

Community engagement will be paramount to the success of this policy proposal.

Fostering partnerships with local governments, businesses, and grassroots organizations will enable us to mobilize public support for glass recycling initiatives. This may involve launching public awareness campaigns, establishing community collection centers, and providing incentives for citizen participation. By combining data-driven insights with stakeholder collaboration and legislative advocacy, we can pave the way toward a more sustainable future for Utah's environment and communities.

II. PROSPECTIVE COSTS ANALYSIS

In formulating a comprehensive policy proposal to enhance statewide glass bottle recycling, it is imperative to conduct a rigorous cost analysis that elucidates the financial implications and feasibility of the proposed initiative. To align with the interests of the Executive Branch Agency, my plan includes Utah-based beverage distributors in the transportation process and designates them as 'Deposit Initiators.' By separating glass in the early stages as much as possible, we can reduce the contamination level of glass and obtain glass cullet with the highest level of purity. The purity of the cullet is the primary factor affecting its market price and, consequently, the profit structure of a material recovery facility. Glass scrap sells at a negative price at 80 percent purity, but cullet with a purity level up to 99 percent can earn about \$100 per metric ton. My plan utilizes the tractor-trailers of the beverage distributors and the hauling trucks of Momentum Recycling for transporting glass to the recycling facility. This approach enables a

glass-only stream collection, minimizing avoidable costs incurred from glass scrap contamination by maintaining the highest level of cullet purity.

Table 1 presents an overview of beverage sales and returns in glass bottles in California, serving as a foundational reference for projecting analogous figures for Utah upon the effective adoption of the Utah Glass Bottle Recycling Program tentatively named as UGRP. The data originates from the Beverage Container Recycling Fund Semi-Annual Report by CalRecycle.

Sales of beverages in glass bottles exceeding 24 ounces are extrapolated from the sales analysis report of the Utah Department of Alcoholic Beverage Service. The count for bottles under 24 ounces is derived from California's data, adjusted by the beer consumption rate for the respective year. The total number of returned bottles in Utah is estimated by applying California's recycling rate.

The principal components of revenue and expenditure within the UGRP financial framework are the program value-in, which is paid by beverage distributors upon selling beverages in Utah, and the program value-out, which constitutes the refund disbursed for the collection of glass bottle beverages. Unlike the California Redemption Value (CRV), which stands at 5 cents for containers of 24 ounces or less and 10 cents for larger sizes, the UGRP reimburses customers' deposits at a rate of 10 cents for containers of 24 ounces or less and 25 cents for larger sizes. This system is designed to incentivize customers to redeem their empty bottles at designated recycling centers and State liquor stores, rather than resorting to curbside collection or disposal methods.

A notable advantage of the UGRP is its utilization of State liquor stores as recycling hubs, particularly given that a substantial portion of beverage bottles exceeding 24 ounces are sold through these outlets. It's important to note that the Utah Department of Alcoholic Beverage

Service exclusively manages State liquor stores. According to the financial summary, the net profit generated from State liquor store operations amounted to approximately \$134,672,000 in FY 2022, after accounting for transfers to various funds. This surplus can be leveraged to cover handling fees associated with collection services in State liquor stores, thereby ensuring a sustainable budget to support Momentum Recycling while upholding a handling fee rate comparable to that of California (refer to Table 1).

The handling fee allocated to retailers, recyclers, and beverage distributors stems from unclaimed redemption value. As a result, an increase in redemption claims directly correlates with a decrease in available funds to cover these handling fees. As the recycling rate escalates, the available fund balance for handling fees is anticipated to concomitantly diminish. However, this nominal outlay pales in comparison to the exorbitant costs associated with landfill

expansion, particularly when factoring in the deleterious environmental consequences of such infrastructural endeavors.

By judiciously balancing handling fees with revenue streams derived from redemption value and transfers from Utah DABS profits, the proposed initiative not only fosters environmental stewardship but also underscores the economic rationale for embracing sustainable waste management practices. As Utah charts its course towards a greener and more resilient future, the proposed policy represents a prudent investment in both environmental preservation and fiscal prudence.

III. FLOW OF GLASS BOTTLE CONTAINER AND REFUND VALUE

When consumers purchase beverages in glass bottles from retail stores, they are required to pay a 10-cent surcharge known as the UGRP Value. The retailer then transfers this surcharge to beverage distributors, who, in turn, send the 10-cent deposit to the UGRP program account, retaining 1.5 percent of the amount as their handling fees. Additionally, it is the responsibility of the beverage distributor to supply retail stores with an adequate number of bags or appropriate containers for packaging the returned glass bottles. The beverage distributors operating in Utah are required, as deposit initiators, to report their quarterly fund balance to the UGRP program.

1. Consumers (UGRP redeemers for 10 cents) bring empty and rinsed glass bottles to a designated retail store. Retailers accept empty glass bottle containers of 24 oz or less, matching the color and brand sold or offered for sale by them. Beverage distributing companies, which play a role as 'Deposit Initiators,' accept from retailers any empty glass bottle container of the size, color, and brand sold or offered for sale by them.

Additionally, State liquor stores, acting as another deposit initiator, collect glass bottles

- of 24 oz or larger, returned for a 25 cents UGRP value-out. They can set a daily limit on the maximum number of bottles to be accepted if their handling capacity is limited.
- 2. Retailers package the returned containers in each bag provided by a beverage distributor and pass them to the distributor when a new beverage enters their business. State liquor stores collect the glass bottles returned and keep them in a pre-prepared UGRP recycling bin for Momentum Recycling to collect at the end stage.
- 3. Momentum Recycling, using its trucks powered by natural gas, collects the returned glass bottles at the beverage distributor's business site, most of which are located in the Salt Lake City metropolitan area, and delivers the glass bottle containers to its recycling facility. They also collect the glass bottles from the bins installed at the State liquor stores. The collecting frequency should be at least once a week to minimize possible contamination, especially in winter when a glass bottle is frozen commingled with rain or snow.

In Table 1, handling fees paid to designated retailers and recycler, Momentum Recycling, are calculated by multiplying the UGRP value-out by 2.5 percent, aligning with the rate in California. However, the projected ending balance in 2023 in Table 1 shows a large margin, allowing the UGRP to afford larger handling fees to retailers participating in the program. For example, reimbursing 3 cents per glass bottle to compensate a retailer for collecting, sorting, and packaging the empty containers, ready for transport, would cost only an additional 1.8 million dollars to the program. This would encourage more retailers to join the UGRP, and customers would be reimbursed 10 cents per glass bottle, regardless of where they purchased the beverage. IV. RECOMMENDATION

Cullet allows glass manufacturers to substitute raw materials, resulting in a 40 percent energy savings because less heat is required to maintain furnace temperatures for melting glass.

This leads to reduced greenhouse gas emissions. However, the high transportation costs associated with glass bottle containers and low efficiency, primarily due to contamination during the recycling process, pose significant obstacles to glass bottle recycling.

In Utah, residential recycling occurs through single-stream curbside collection, where glass bottle containers are mixed with other recyclables. Implementing a new recycling plan that separates glass bottle containers into a distinct stream would enhance cullet purity, thereby improving the cost efficiency of glass bottle recycling. Charging a 10-cent redeemable deposit to customers who purchase beverages bottled in glass containers can serve as a recycling 'nudge' and contribute to the preservation of our sustainable environment.

Additionally, I suggest that the abbreviation 'UT' be prominently displayed alongside 'OR' on every glass bottle container, similar to the successful recycling efforts managed by the Oregon Beverage Recycling Cooperative, which is owned by beverage distributors in Oregon.

Dear legislative leadership,

The Westside Coalition advocates for the health, safety, and quality of life of Westside Salt Lake City residents. Our board includes representatives from the six Westside community councils, as well as other leaders elected by the community.

We write to urge you to approve funding for the housing and homelessness initiatives outlined in Governor Cox's budget. We know you have seen the devastating impacts the housing shortage, combined with the opiate crises, have had on Salt Lake City communities, especially on the Westside. While this may seem like an urban issue, in fact Salt Lake City is merely landing place for a statewide homelessness crisis.

The Governor's budget includes many bold proposals that experts tell us will go a long way toward addressing these issues in a lasting and meaningful way. However, it appears that only a fraction of the requested funding has been allocated. The funding currently anticipated isn't enough to cover services already being provided, let alone make any real progress.

We know funding is tight this year, but addressing this crisis is an urgent priority. It is unlikely state investments in the Westside and downtown areas aimed at sports and entertainment will succeed without substantial progress on homelessness.

If it is not possible to fully fund all of the homelessness initiatives in the budget, we ask that you prioritize: \$2.5 million to the Shelter City Mitigation fund and \$25 Million for Low Barrier Shelters. The mitigation fund is vital to maintaining the status quo in our neighborhoods, and we believe low barrier shelters are the most important next step towards making our communities *and* unhoused populations safer.

Thank you for considering our input. We look forward to working with you in partnership on these important matters.



The suspension – preferably 90 days – would allow you to initiate a joint convening process with the Yalecrest Community – which borders Sunnyside Park and the proposed land lease property – and other stakeholders (city and university) to understand how the loss of this land could trigger social, environmental and recreational impacts. Thus far, neither the city nor the U have sufficiently demonstrated how this land transfer is in the public interest and or offers real public benefits. For 40 years, the Yalecrest community has played a leading role in shaping what is now called the Salt Lake City Sports Complex – which includes a portion of the BLM petition land the city wants to lease. Community leaders like Kimball and Laurel Young, James and Maryann Webster, Betsy Hunt, Bob Bridge, Steve Lowe and Ramone Johnson raised millions in private money so the Sports Complex could be built on the petitioned land. The pool is called the Steiner Aquatic Center in honor of Bob Steiner's generous donation. The Complex used to represent the best of public-private partnership. That partnership is now under assault. To ignore the contributions and opinions of these loyal residents and others in assisting the BLM to fulfill it

			who take time to listen till the very last comment, who show up for dialogue and who consistently have pleaded
			with you to recognize the disparity of treatment among the Palestinian people and their Occupiers, have once
			again fallen on deaf ears. I honestly do not understand why you physically cannot say the word ceasefire. On
			Tuesday there were comments from the Jewish community toward Palestinians, and those who are echoing their
			cause, that sounded much like coded comments used to stifle members of other minorities. It sounded as if they

			sudden stop to the literal and ongoing destruction of the people of Gaza, is equal to a theoretical extermination
			of Jews everywhere, even in Salt Lake City. Do you recognize the ludacris notion of these comments? Do you not
			see through them? This is why it is so disappointing to read your resolution of joint peace. Not even in a
			ceremonial act can you say that Palestinian lives matter, that the children of Gaza exist and deserve a future,
			that bombing Palestinians daily and detaining innocent civilians is undeserving and criminal. The resolution was
			unapologetically vague and full of fluff. Did you mean to leave out the place where there's a "terrible loss of life"
			and where the "international conflicts" are taking place? Every day I continue to watch more children become
			orphans, more families literally being blown apart, women having babies in tents and the heavy gloom on their
			faces when they can't eat or feed their children. Please do not look away from their suffering and say there is
			nothing you can do. Obviously, the members in your community believe you do have the power to change our

			your resolution to include specific language that recognizes the need for an end of violence in Gaza and that the
			30k+ deaths are a tragedy and do not go unnoticed by the international community and the City Council of Salt

Statement Regarding Salt Lake City's Silence on the Gaza Conflict

As concerned residents of Salt Lake City, we are deeply troubled by the lack of acknowledgment and action from our city leaders regarding the ongoing conflict in Gaza. The recent resolution passed by the city council fails to address the urgent humanitarian crisis unfolding in Gaza, where innocent civilians are facing unimaginable suffering due to relentless bombing, blockade, and denial of essential aid.

Salt Lake City, as a community that upholds principles of compassion, justice, and human rights, cannot remain silent in the face of such egregious violations. The Salt Lake City Code of Ethics clearly outlines the responsibility of our city to promote the well-being and safety of all individuals, both within our borders and beyond.

By turning a blind eye to the plight of the people of Gaza, Salt Lake City is effectively condoning the actions of a government that perpetuates violence, terror, and genocide <u>against its own</u> <u>citizens</u>. This is in <u>direct violation of the values and principles that our city claims to uphold</u>.

By failing to stand against the violence and aggression in Gaza, Salt Lake City is effectively sanctioning these atrocities and betraying the trust of its own citizens. This complicity makes our residents feel unsafe, threatened, and betrayed by their own government and elected officials.

Furthermore, the resolution passed by the city council fails to fulfill its duty to protect vulnerable populations, including refugees and displaced persons, who are among the most affected by the conflict in Gaza. By not speaking out against the atrocities being committed, Salt Lake City is complicit in the suffering of innocent civilians and is effectively supporting state-sponsored terrorism.
