As you recall, we are trying to get Salt Lake City to amend building standards so that new construction projects adopt bird-friendly windows and design. You led the Salt Lake City Council to a unanimous straw vote in favor of bird-friendly window standards, with requests for additional detail. Since then, we have met with Kelsey Lindquist and Amy Thompson, Planning Managers with SLC, who were very helpful. They provided a number of questions, which we have tried to address with a draft ordinance, a background document that fleshes out the ordinance with research, and an evolving FAQ document (attached, along with a pdf of this letter). We also agreed to work closely with planning; we can provide any research or responses as needed. Ms. Thompson and Ms. Lindquist said we would need to get the council and staff to communicate some sort of priority for this work to the planning staff. They suggested we reach out to Brian Fullmer and Nick Tarbet, and perhaps Rachel Otto. I wanted to link you in first, to update you and see if you had any additional questions. 3/13/2024 11:18	Jim Webster	U baseball land lease	Dan, I continue to find it impossible to provide comment on the physical limitations of the site for a baseball stadium absent verified ALTA topographic mapping, cross-sections of retention walls and related elevation drawings from the U. I seriously question that SLC Engineering and Public Utilities do not also share this concern. No verifiable review has been conducted, as is otherwise required for basic planning approvals in SLC. I understand from second-hand conversations with those who have seen Tyler Murdock's "public benefits" analysis that it has only become available within 24 hours of the Council's vote to approve the land lease. This is absurd. Although I've not seen it, Tyler apparently believes the right field wall, after consummation of the lease will be 29' in height, a mere 8% reduction relative to the 35' version on existing U land. Given available aerial topography, the retention wall at left field will be a minimum of 22-24' high. The ONLY reason for extending left field into Sunnyside Park is to enable spectator seating on the right field line as the existing practice field home is arbitrarily moved 93'. This contradicts prior assertions presented to the community by the U. Sufficient distance re. NCAA standards is in place without the need for a lease or land sale. Other statements by Robin Burr to the YNC have also proven to be mistruths. The Council's assertion that the city will continue to own the property appears to enable a loophole to satisfy the BLM's requirement to perpetuate public recreational use. Regardless of ownership status, the NCAA has prohibited public use of the practice field despite the U's past promises to the community. Nothing will, or can change this. Impacts due to storm runoff from synthetic turf have not been adequately evaluated. FieldTurf contains carcinogens. The city administration did not require RHSM's contractor to adhere to the approved storm water retention vault. This resulted in flooding at East HS and unprecedented taxpayer expense. I am writing in support of the Friends of Sunnyside Park. It has come to my attention that a section of land involved in a proposed land lease agreement between the City of Salt Lake and the University of Utah is under the control of the Department of Interior, Bureau of Land Management (Source: BLM land patent #43-90-0014, signed February 16, 1990, pursuant to the original Act of June 14, 1926). As such, neither the city nor University is currently authorized to consummate this agreement. I am writing to request you to set a 90 day reprieve on any decision by the Salt Lake City Council to grant a transfer of that land from the BLM to the City or University of Utah until further information on the proposed University of Utah baseball stadium project is provided to the public. Currently, that land is part of city public open lands (Sunnyside Park). The ambiguity about the baseball stadium project versus the original intent for this land to be used to create an extension to the existing Salt Lake Sports Complex (previously named the Steiner Aquatic Center) by City approved East Bench Master Plan (1987, 2017) dictates more information before finalization. (And eventually for those of Zephyr Lofts.) There seem to be no signs posted indicating it is a public park, or regarding the leash status of dogs. My understanding of city and county ordinances is that, by default, all public spaces require a leash, unless specifically posted otherwise.  Unfortunately, many people seem to think that it's private property (I've had a Paperbox resident express this belief to me), or are unaware of the law (or unwilling to follow it). Just today I witnessed a scuffle between dogs (one off leash) where at least one of the dogs yelped in pain at one point. I think the owners had them make up, so no real harm done it seems. Later, when I went to check the signage, I had the unpleasant opportunity of being humped by a husky wearing a pink vest, and an owner who refused to control his dog when asked (he preferred to question my lack of bravery).
