My name is Scott Narus and I represent a homeowners association located on just north of (District 6). I'm here tonight to express our concerns with the new Stabilization Fees added this past month to all City utility bills. The new Fees are flat fees based on the size of a customer's water meter and not actual usage. When our homes were built in 1988, a single, 4-inch water meter was installed to distribute water to all 10 homes in our HOA. Based on our meter size, the added Stabilization Fees for water, sewer and 6% franchise tax total \$790 per month, which equates to \$79 per HOA home per month. A typical single-family home has a \(^3\)-inch water meter, and the new stabilization fees for such homes come to \$18.44 per month. In other words, our homeowners are being asked to pay over 4 times as much as the typical home. Additionally, our HOA's average monthly water, sewer and franchise costs during the preceding 12 months totaled \$918. The \$790 in new charges equates to an 86% increase over what we are already paying, and this is before factoring in newly increased rates for City services. This will result in both a substantial assessment against our homeowners for the remainder of 2024, and a significant increase in our monthly HOA fees in 2025. Most of our HOA residents are retired and on fixed incomes, and this level of increase is unexpected and challenging for personal finances. Let me be clear that we are not asking for special treatment. The impact of the fees is not unique to our HOA. Other small, multi-home groups in the City are severely affected by this new expense, too. Interestingly, the fees charged to us are the maximum amount for any customer with a 3-inch or larger meter. Thus, a larger multi-home association – or business – with the same or larger size water meter has the same new fee amounts as us; this means that an association of 20 homes, for example, would pay half as much as us per home. I find it hard to believe that the Council would impose such an increase knowing the relatively large and inequitable nature of these new fees. The City's own explanation for the new fee methodology says it was based on sustainability and equity goals, but, as I have explained, these goals have been ignored. The added expenses will lead to growing unaffordability for all homeowners in our situation. Therefore, we are asking the Council to either suspend the fees or set a temporary maximum fee increase based on current use, until a more thorough impact analysis is performed. We also request that the City provide correspondence as soon as possible on intent to address this issue so that everyone impacted will know if it is being considered. Thank you.

One of the key components of the master plan, that I believe is integral to accessibility and usability of the Foothills Trail System is the development of trails and specifically, the development of use-specific trails. While I understand that there are concerns about building downhill bike trails, and how that impacts hiking users of the trail system, I believe strongly that the development of downhill only trails is integral to the future development of this area. As is the case at many nearby recreation areas (Corner Canyon and Park City, for example) having downhill only bike trails increases the safety and accessibility of all users. The foothills area is used extensively by both cyclists and hikers. While hikers may be uncomfortable with being told they cannot use a downhill mountain biking trail, to neglect the benefits of downhill only trails is to neglect that cyclists regularly use this area. Since cycling has been, and will continue to be, a significant use of this area, I believe that the best way forward is to acknowledge that and plan accordingly. Furthermore, the population of Salt Lake City is growing quickly, with one of the large appeals to many moving to the area is the accessibility of outdoor pursuits to the city. Expanding the trail system will increase this access and provide greater good to a greater number of users. I understand the concerns from residents of the area that the trails they know are changing, however I am concerned that these objections are made by a small group of people whose concerns are narrow in scope, failing to understand the value of public lands to the more general public. While demands for more thorough environmental impact assessments may appear to be well-meaning, I believe this is a tactic may simply be used to delay the project or reduce its feasibility.

We agree with the change to add "Hospital" and "Ambulance Services" to the allowed uses for the D-1 Central Business District zone. This is a good location for this hospital, much easier to get to than the current LDS Hospital location. We know the University Hospital is also a Trauma I hospital, and close at hand, but adding this one is a big boon to the west side of our city. Driving in a vehicle, even in a fire truck or ambulance, from the west side up to the University Hospital is difficult, especially during high-traffic periods. This should allow those patients needing quick trauma care to receive that more quickly. We ask that special care be taken to locate exterior retail around that site. An entrance on the south (in addition to wherever else they put them) should allow patients and staff to use it. This will allow more foot traffic to the retail uses like Taco Time on the south. It may need a security guard, like the City Building has on the first floor, just to be sure that people entering have a reason to be there, not to just wander. We know the homeless center is nearby and don't want to make this a place where the crowds gather. They already congregate along 700 South clear up to Taufer Park. Maybe a coffee shop on the south run by IHC would help. We aren't sure exactly what the solution is, but we don't want to create another nuisance area in the city, we have enough. and at the same time, we don't want to cut off the local businesses around the building from customers. 		System Plan	runner and cyclist, a mountain bike coach, and an advocate for Utah's open spaces. In the fall of 2015, when I was a member of
			Salt Lake City's Parks, Natural Lands, Urban Forestry, and Trails Board, I approached Lewis Kogan with some concerns
			regarding trails in the Foothills. I have witnessed many, and even been involved in, user conflicts while recreating on those
			trails. I have been bitten by an off-leash pitbull, defended my sons when chased by off-leash dogs, been hit by a descending
			mountain biker in Dry Creek, and been yelled at by hikers claiming that the Foothills are off limits to bikes. Lewis and I
			discussed some of those issues, I asked that the City consider adopting a plan and formally adopting and expanding the trails
			system, and I have followed the proceedings rather closely since then. I have recreated in SLC's Foothills for as long as I can
			remember (even back when we could drive trucks from North Salt Lake to the radio towers above Ensign Peak). They are one of
			the things I missed most while living out of state for eight years. Although I returned 15 years ago, I'm daily in awe of the
			Foothills and the peaks they sometimes hide. They've built in my sons and me an appreciation for nature, a love for our natural
			resources, and a desire to protect our open spaces. My spouse was hit by a drunk driver while riding her bike eight years ago;
			while I previously spent thousands of miles on a road bike each year, that episode changed us. We sought refuge in the
			Foothills—running, hiking, and biking to escape, if only for a moment, our own thoughts and the noise of city life. I recently
			created a map of my activities in the Foothills, and that map shows hills blanketed in red lines where I've seen elk, moose,
			mountain lion, and countless fellow runners, hikers, and bikers. My sons joined NICA (the high school mountain bike league, of
			which Utah's over 7,000 student-athletes make it the country's largest chapter), and the Foothills have become their escape—whether from a long day at school, peer pressure, and especially during the days of social distancing, remote
			learning, and Zoom classes. As a dad and coach on our East High team, I've loved introducing new riders to the Foothills,
			whether overlooking This is the Place State Park at sunset, marveling at spring's balsam root-covered hills, or peering into City
			Creek Canyon (forbidden to mountain bikes). Our team has more than doubled in size in the last three years, and other teams
			at City schools (including West, Highland, Judge, SLCSE, and a Composite team from other area schools) have seen similar
			growth. We're teaching these hundreds of new trail users to exercise appropriate etiquette, to care for their public lands, to give
			back by helping maintain trails, and to encourage their families and friends to do the same. In fact, the response from these
			kids has on more than one occasion overwhelmed the City's capacity to accommodate the kids' volunteer requests—even
			when they're working on hiking-only trails! Anticipating increasing demands for trail space, and being disappointed at seeing
			Salt Lake City fall behind cities throughout the West in trail building (whether conservative cities like Bountiful, Draper,
			Herriman, St. George, and Boise, or progressive cities like Moab, Boulder, and Park City) were some of the motivations behind
			my discussions with Lewis back in 2015 about a plan that would permit City residents to recreate from their homes, rather than
			having to drive to Draper or the Wasatch Back (it's silly to have to drive a car to ride a bike). Years later, I was happy to hear that
			the City adopted a plan (following public input) to give its residents better access to its Foothills with more, better trails. The
			BST (and its large number of social-trail offshoots, many of which are unsustainable, and some of which suffer severe erosion)

			Where appropriate, users could be separated to provide a better, safer experience. And while I'll miss running some of the trails
			I used to run, or riding some of the trails I used to ride, I am thrilled to see a generation of runners and riders learn to love our
			open spaces, discover there is more to life than Minecraft, and accomplish challenges they previously found daunting. The City
			went to great lengths to inventory public lands, get public input, develop a plan, get input on that plan, and adopt that plan.

			loud users (runners and riders alike—I've even seen motorcycles at Morris Meadows); by people illegally parking in areas where
			parking is already pinched; etc. Clearly, something needs to be done. But SOF were conspicuously quiet when the University of
			Utah tore up the Foothills in connection with the water tower construction. They were again quiet when the bulldozers and
			tankers turned the area behind the medical center into a construction site, burying old trails and displacing countless users,
			creating massive dirt roads that have yet to be fixed. No SOF protests, no signs—I'm guessing because it didn't impact their
			parking despite the massive and permanent hillside scarring (including a new paved road) and crushed balsam root. The fact is
			that more trails are better for everyone, and a variety of trails is better for everyone. While I enjoy riding a bike downhill, I don't
			believe that every trail should be a downhill mountain bike trail. As a hiker and runner, I don't believe that all trails should be
			accessible only to those on foot. That said, it makes sense to separate users at times. Take the Armstrong Trail in Park City, for

Even the most dismissive viewer would acknowledge that the rutted fall-line trail near the JCC is in terrible condition and dangerous—it has sent my son to the hospital on a crash from his bike, and it has left me bruised and bloodied from a fall while running. • Cities find significant economic benefit when building trails – as users have a better experience, they visit a city more often and spend more money locally. • Given the dearth of suitable trails in SLC, accommodating the approximately 300 kids enrolled in mountain bike programs at Salt Lake City public schools requires those teams often drive those 300 kids (plus coaches and parents) to Park City, Draper, or other local trails, multiple times per week—this is not great for our vehicle traffic and air pollution concerns. This is true of other riders as well—many riders find themselves having to drive to distant trailheads because of overcrowding and lack of suitable trails in Salt Lake City. • Utah High School Mountain Bike League growth is up exponentially, with the league splitting into two regions in 2016, three regions in 2018, four regions in 2020, and six regions in 2022 with over 7.000 student athletes. • Student athletes from Millcreek, Holladay, Draper, Woods Cross, North Salt Lake, and Bountiful often ride in Salt Lake City given the low-elevation trails with soils conducive to early season riding. • Bike sales surged 69% in 2020 vs 2019, and have only grown since then. • The demands placed on Salt Lake City's trails (few of which are suitable for beginners or lower intermediate riders) are skyrocketing. Dear Councilman Dugan:

Sometimes I wonder. The city is spending considerable amounts to restrict driving in the downtown area, hoping to encourage the use of mass transit, bicycles, and walking. Significant traffic flow changes have been made on South Temple, Second South, Third South, and recently West Temple. (I have driven along West Temple most days for thirty years. I don't recall ever seeing a bicycle on that street – a scooter or two on the sidewalk, but no bicycles.)

At the same time, the City Council encourages billionaire Ryan Smith to build two or three (unknown number) high rise buildings along South Temple Street. No doubt, these buildings -- whether office, residential, or hotel – will inevitably and dramatically increase automobile traffic in the area. The two Council actions are so obviously contradictory that one wonders how (or if) City Concil minds work.

At the same time, if Smith builds his high rise buildings, it will require a complete rebuild of the Convention Center because a significant part of the Center now extends to South Temple Street. The questions city residents ask are: What will the new Convention Center look like? Who will pay for it? How much convention business will we lose in the process?

Smith also says he intends to preserve Japan Town. He's a few decades too late for that. However, preserving Japan Town seems incompatible with rebuilding the Convention Center, especially if, as some planners propose, First South Street is re-opened below West Temple.

At some point, City Council members should ask for (demand) a schematic representation of plans for the so-called "Entertainment District," including its effect on adjacent blocks. City residents deserve to know a great deal more before their full approval can be expected.
