Selected members will be expected to 1) meet at least twice a month from February until the Council adopts new boundaries by the end of April 2022 to May 10, 2022, 2) attend meetings to gather concerns, ideas, and input, 3) present a list of guiding values and considerations for District maps, and 4) present suggested maps of Council District boundaries for the City Council's consideration.
