MEETING HIGHLIGHTS

Tuesday, Oct. 8, 2024

North Temple Project Area Boundary Adjustment

The Council, acting as the Redevelopment Agency (RDA) Board, adjusted the North Temple Project area's boundaries to align with [state legislation](#) passed earlier this year. The legislation created the Utah Fairpark Area Investment and Restoration District, which will support the development of an MLB stadium in the Power District.

Extending the S-Line Streetcar

The RDA Board also approved the transfer of nearly 14,000 square feet of land along Simpson Avenue to Salt Lake City to extend the S-Line Streetcar to Highland Drive. The land, which includes the old Sugar House Deseret Industries, a former fire station, and a maintenance shed, will become the site of a new S-Line station. The State Legislature previously approved \$12 million for the rail extension and a new station.

Affordable Housing Wealth Building Program

The RDA Board received an update on the Wealth Building Notice of Funding Availability (NOFA) Opportunity. The board had previously set aside \$2.8 million to develop a pilot program focused on affordable housing. They additionally allocated around \$417,000 from the Salt Lake City School District's tax increment towards family and workforce housing projects with three or more bedrooms.
