The Salt Lake City Police Department applied for and has received a \$15,000 grant award from State of Utah, Department of Public Safety, Alcohol & Drug Fee Committee. The funds are to purchase wireless communication kits for its Motor Squad officers. A public hearing was held on 12/13/16 for the grant application on this award.

G-2: State Office of Crime Victim Reparations, FY 2017 VAWA Grant Misc Grants \$16,515.54 Department: Police Department Prepared By: Wendy Isom / Melyn Osmond

The Police Department received a \$16,515.54 grant from the State of Utah, Office of Crime Victim Reparations for the continuation of their FY 2016 VAWA funded Victim Advocate Program. These funds will be used to continue to pay .43 FTE of the salary and benefits of an existing victim advocate who provides on scene crisis counseling and information pertaining to resource services to victims of domestic violence; and will be used for monthly cell phone plan for the Victim Advocate. The PD receives this grant on an annual basis.

A 25% match is required which will be satisfied by the payment of salary and benefits of the victim advocate program coordinator. These funds are budgeted for within the Police Departments general fund budget. A public hearing was held on 11/1/16 for the grant application on this award.
