Final Results of the
Public Support Survey of Property Owners

Proposed Yalecrest - Harvard Heights Local Historic District

The proposed Yalecrest - Harvard Heights Local Historic District was reviewed by the Historic Landmark Commission on January 7, 2016, and the Planning Commission on January 27, 2016. Both commissions voted to forward recommendations to the City Council to designate the local historic district.

Prior to transmitting the recommendations to the City Council, the City is required to determine the property owner's level of support for the designation of the proposed local historic district. To determine the level of support, a ballot was mailed on March 18, 2016, asking if property owners were in support, or if they were opposed, to the designation. Ballots were required to be submitted to the City or postmarked by April 18, 2016.

The Salt Lake City Recorder's Office tallied the ballots on April 22, 2016, and issued an Official Canvass (see attached) of the balloting and found that:

- 29 Property owners VOTED IN SUPPORT of designating the proposed local historic district, and
- 8 Property owners VOTED IN OPPOSITION to designating the proposed local historic district

The proposed designation of the Yalecrest - Harvard Heights Local Historic District will now be transmitted to the City Council for consideration. As part of the City Council's review, an additional public hearing will be scheduled prior to the City Council making a final decision. Since the number of ballots received in support of designation of the Yalecrest - Harvard Heights Local Historic District exceeded the number of ballots received in opposition, the City Council may designate this local historic district by a simple majority vote (at least 4 Council members voting in support). You will be notified when the City Council schedules a date for the public hearing.
