

Q1 Did you know that Salt Lake City has a Trails & Natural Lands Program?









Q4 On average, how often do you use foothill trails, including the Bonneville Shoreline Trail?





Q5 Most often, how do you access foothill trails?



Q6 About how far do you live from the Salt Lake City foothills?



Q7 Which of the following BEST describes how you feel about trails in the Foothill Open Space Area?







Q15 What is your gender?




