ARTICLES OF INCORPORATION

of the

BONNEVILLE HILLS COMMUNITY COUNCIL

We the undersigned acting as incorporators of the BONNEVILLE HILLS

COMMUNITY COUNCIL, a non-profit corporation of the State of Utah, herewith submit to the Secretary of State, signed and verified Articles of Incorporation for said corporation for such purposes and under such conditions as are specifically set forth hereafter as follows:

ARTICLE I

The name of the non-profit Corporation shall be:

BONNEVILLE HILLS COMMUNITY COUNCIL

ARTICLE II

The period of duration of the Corporation shall continue perpetually unless sooner dissolved according to law.

ARTICLE III

The objects, purposes and scope of the Corporation shall be as follows:

- A. Educate the community about issues and activities concerning the Bonneville Hills community and surrounding areas.
- B. Encourage involvement of neighbors through monthly meetings, volunteerism, street fairs, and other community events including block parties.
- C. Encourage the improved walkability of neighborhoods by having maintained sidewalks and drainage systems, more trees, maintained yards and gardens and improved lighting.
- D. Encourage places that support relationships among residents, including small business, coffee shops and clean recreation areas.

- E. Support an adequate number of law/safety officers to meet the needs of the community, in combination with crime prevention programs and citizen involvement.
- F. Support historic preservation.
- G. Support the increased maintenance and enhanced improvements of parks and areas that are for the multiple uses of all residents.
- H. Promote neighborhood involvement for well thought out traffic control and planning, and utilization of public transportation.
- I. Plan today for the residents of tomorrow
- J. Provide a common voice for the residents of the Bonneville Hills area of Salt Lake City, before elected governing bodies, service agencies, public and private, the community at large, and other organizations and/or individuals, concerning community issues.
- K. Disseminate information to the Bonneville Hills area residents about events and issues that directly affect the life of the Bonneville Hills area and individual residents thereof.
- L. To preserve and improve the business, residential, recreational areas and facilities of area-boundaries: 1300 South; 1700 South; 1900 East; Foothill Drive
- M. To receive, invest and disburse funds and to hold property for its purposes.
- N. To receive gifts and contributions or real and property from the United States of America or any agency thereof, from the State of Utah or subdivision or agency thereof or from any charitable organization, person, firm or corporation for use in furthering its purposes.
- O. To do all of the aforesaid without contemplation of any pecuniary gain or profit to the members thereof so that no part of the net earnings or property of any kind belonging to this corporation shall inure to the benefit of any private shareholder, member or individual.
- P. The foregone enumeration of specific purposes and objects shall not be held to limit or restrict in any manner the powers of the corporation, but shall be in furtherance of and in addition to the general powers conferred by the Utah Non-Profit Corporation and Cooperative Association Act and by all other laws in the State of Utah, all of which powers this non-profit corporation shall have.

ARTICLE IV

The Corporation shall have members and membership shall be open to all persons residing or owning property in that area of Salt Lake City as described above, upon such terms and conditions as shall be provided by the By-Laws of the Corporation. Members shall not be individually or personally liable for the debts and obligations of the Corporation.

ARTICLE V

No shares of stock will be issued by the Corporation and none will be required for membership.

ARTICLE VI

The affairs of the Corporation shall be managed by a governing board called the Board of Trustees. The Corporation shall have such number of trustees, but not less than four, as the By-Laws shall provide. The Board of Trustees shall be vested with the power to adopt, amend, or repeal the By-Laws of the Corporation.

The initial Board of Trustees shall consist of four officers, three directors and one registered agent whose names and addresses are:
