We, the undersigned, acting as incorporators of the Capitol Hill Awareness Team (CHAT), a non-profit corporation of the State of Utah, herewith submit to the Secretary of State, signed and verified Articles of Incorporation for said corporation for such purposes and under such conditions as are specifically set forth hereafter as follows:

ARTICLE I

The name of the non-profit corporation shall be:

ARTICLE II .

The period of duration of the corporation shall continue perpetually unless sooner terminated according to law.

ARTICLE III

The objects, purposes and scope of the corporation shall be as follows:

(a) It is organized as a non-profit corporation under the laws of the State of Utah.

(b) To combat neighborhood and community deterioration.

(c) To provide for city beautification, to recognize the historic character and values inherent in the area and to

ARTICLE IV

The corporation shall have members and membership shall be open to all persons residing or owning property in that area of Salt Lake City as described above, upon such terms and conditions as shall be provided by the Bylaws of the corporation. Members shall not be individually or personally liable for the debts and obligations of the corporation.

ARTICLE V

No shares of stock will be issued by the corporation and none will be required for membership.

ARTICLE VI

The affairs of the corporation shall be managed by a governing board called the Board of Trustees. The corporation shall have such number of trustees, but not less/than nine, as the Bylaws shall provide. The Board of Trustees shall be vested with the power to adopt, amend or repeal the Bylaws of the corporation. The initial Board of Trustees shall consist of nine persons whose names and addresses are:

Because of the renaming of streets in the city, the Capitol Hill Neighborhood Council, also known as the CHAT Council, hereby submits a clearification of its boundaries, as follows:

To the North: The North City Limits.

To the East: A street and City Creek

To the South: South Temple Street and the Union Pacific station area located at South Temple and 400 West.

To the West: The Denver and Fio Grande and Union Pacific railroad tracks that curve at an angle and go approximately from 500 to ICOO West just east of Highway I-IS separating one neighborhood from another. This Capitol Hill Council area includes the area bounded by Everett and 18th North, and the Union Pacific station at South Temple and 400 West.
